There were also vehicles beside me crossing said junction at the same time.

After crossing said junction, I was travelling straight along the same lane when suddenly, I felt a huge impact from the right portion of my vehicle just as my father shouted.

My vehicle rocked sideways as a result of the impact.

I immediately came to a stop and alighted from my vehicle to realise that SMT7663G had crashed into the rear right portion of my vehicle after it had turned out from Orchard Link on my right.

The driver of SMT7663G was aggressive and fortunately, police arrived and advised both our vehicles to move off as nobody was injured at that point in time.

However, the following morning, I woke up with soreness and aches in my neck and back areas.

I went to Viva Medical Grp Canberra Plaza to seek treatment on 17/12/22 and was given 3 days MC from 17 - 19 Dec 2022.
