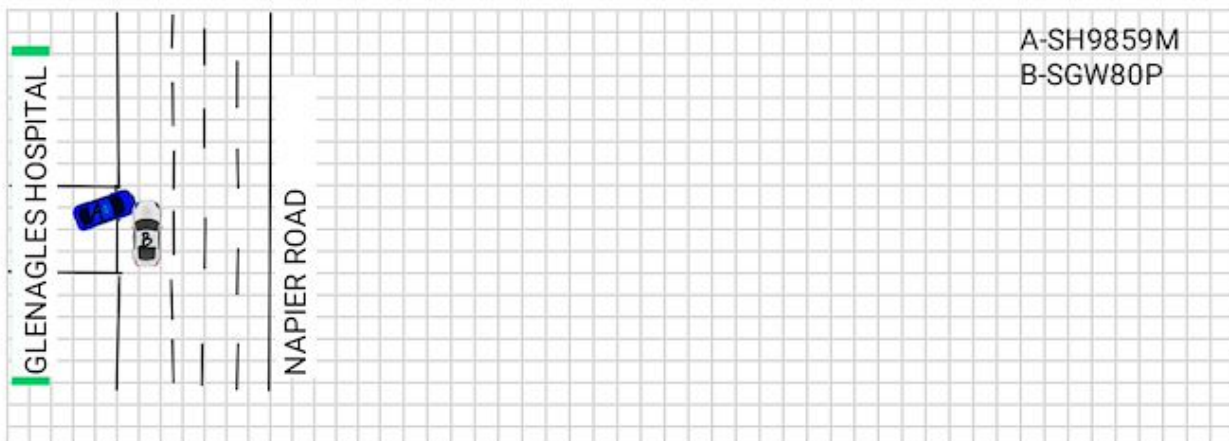

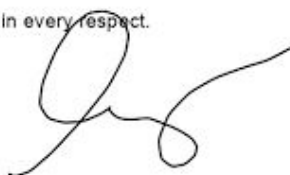
Sketch Plan

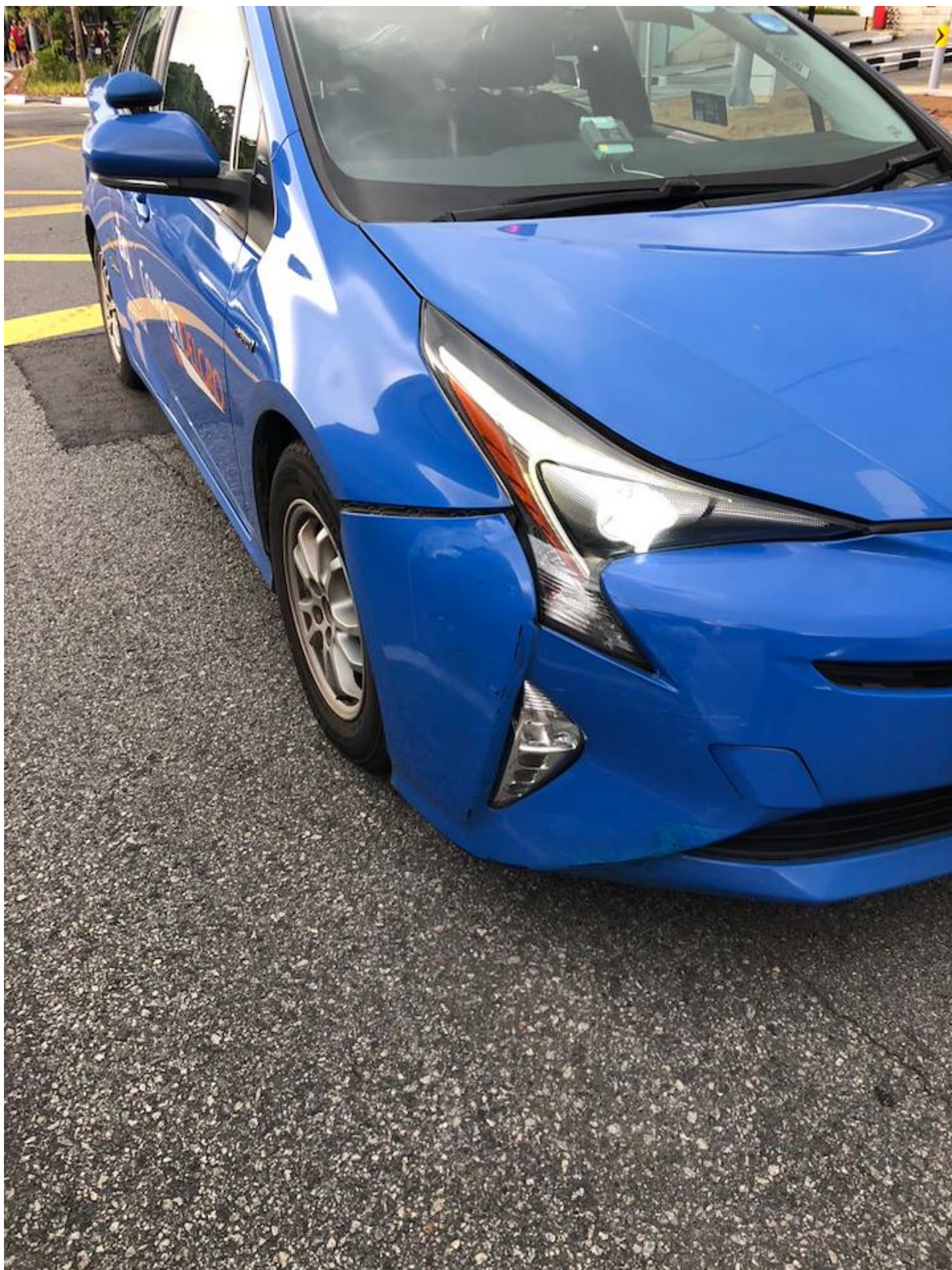
