



Sketch Plan

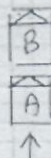
