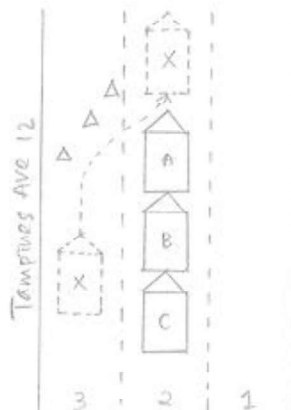

On 8/8/2022 around 2:00pm at Tampines Ave 12, there was 3 traffic cone on the most left lane (^{3rd} lane).



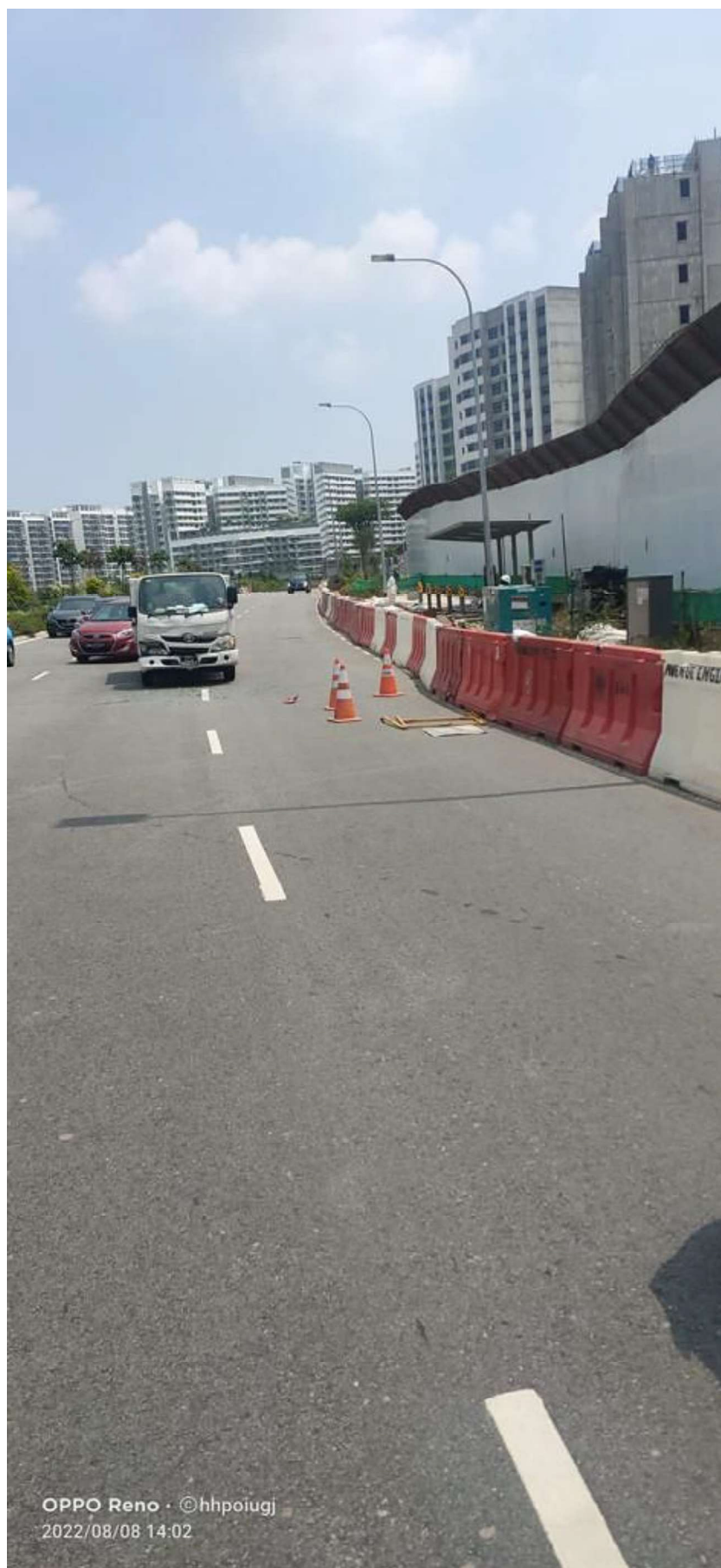
