Kindly assess and appoint an Officer for this case.

The attached are the claim breakdown, accident statement, vehicle inspection report and receipts.

I am unable to send the Prelim Incident Report done by the unit due to the classification of the document.

However this was an incident of the said civilian vehicle which came into Selarang Camp on 21 Jan 2021 and the bollard activated itself (independent of user input) near the entrance, thrusting upwards into the front of the vehicle, causing damage to the bumper as the vehicle came to a complete stop. The vehicle was stationary in front of the bollard before inching forward. Hence it was no more than 15km/h when the incident happened. Unit had since gotten contractor to do maintenance on the bollard to prevent future incidents of such. No one was injured and no other vehicles were involved in this incident.

We are requesting a survey and determine whether the claim amount of \$8,340.70 is reasonable, and in your professional view, what would be a reasonable amount for the cost of repairs to the vehicle. Do assess and review the documentation provided by the claimant's solicitors, such as the vehicle inspection report and the photographs of the damaged vehicle, before advising us on what would be a reasonable amount for the compensation in light of the damage caused to the vehicle.

Let me know if you require anything further and also kindly provide the quotation for this service for us to do up an AOR.
