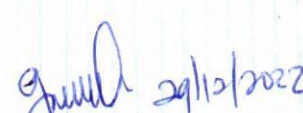

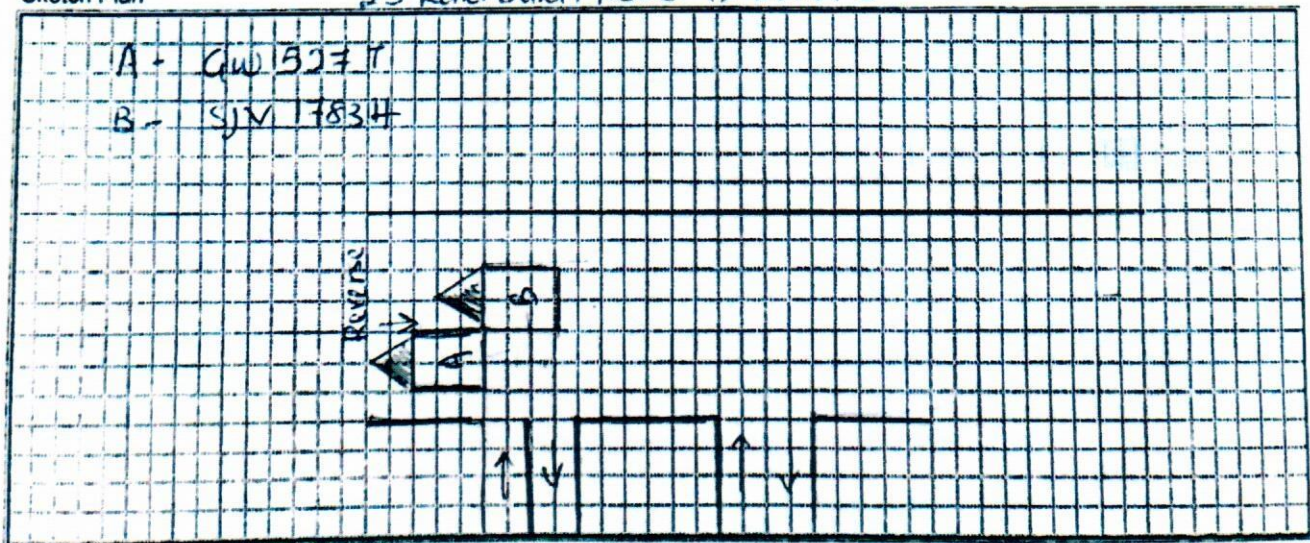

Describe Circumstance of the Accident

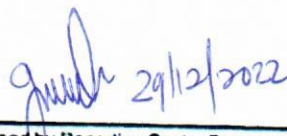
I was reverse my van. Didn't notice a car behind
