Brief Details.

On 21/12/2022 I Teo Kok Eng Michael NRIC S0037507A was driving along CTE Lane 2 towards the city and came to standstill within my lane (at Coordinates 1.33316N, 103.86216E as indicated by my iPhone) when the vehicles ahead stopped. About 2-5 seconds later SJZ5230P collided into the rear of my stationary car on the left hand side.

The driver of SJZ5230P was Goh Ee Shuen, NRIC S8931186A of 326C Anchorvale Road #14-276, Singapore 543326. I am informed SJZ5230P is insured by China Taiping Insurance (S) Pte Ltd.

The time of the traffic accident was 11:48:37 as recorded on the BlackVue dashcam. The MicroSD card was collected by the attending traffic police officer at the accident scene.
