May I seek your assistance to perform a detailed mechanical inspection of the following **16 cases** in the table. The ones marked in **red** are deemed to be **urgent**.

1	TP/IP/28682/2022	<p>On 22 October 2021 at about 1206 hrs, Driver of motor car SME1055E was along Bukit Panjang Ring Road towards the direction of Pending Road, making a right turn into Bukit Panjang Road towards the direction of Woodlands Road when he alleged that there is mechanical fault with the vehicle causing him to lose control of the vehicle. The vehicle veered to the right, mounted the center kerb and to hit onto the railings. No one was injured in the accident and driver claimed there was a mechanical fault on the vehicle. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.</p> <p>As this is a BlueSG electric vehicle, BlueSG personnel was at scene to assess their vehicle and subsequently, I received an email from BlueSG with regard to the assessment of the vehicle after the accident. The email state that it has high risk fire hazard, the vehicle was returned to BlueSG and they are informed not to perform or carry out any repairs. <u>The vehicle is currently not in TPVP premises.</u></p>	SME1055E - Driver (Potential Defendant)	Alex
2	TP/IP/24186/2022	<p>On 8 September 2022 sometime before 5.23 a.m., the Involved Party was driving his lorry when the vehicle skidded. Driver claimed that the steering wheel wobbled intermittently for 30 minutes before it got locked and unable to steer his vehicle. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.</p>	YN1461B - Driver (Potential Defendant)	Valerie Ho

3	TP/IP/30070/2022	<p>On 1 November 2022 sometime before 7.26 p.m., the involved party was driving his car along Nassim Road towards Tanglin road on the single lane two-way road when he lost control of his motorcar, which resulted it to collide onto a tree by the left side of the road and ended up toppled on its right side. Deceased, front passenger of motorcar sustained multiple injuries and was pronounced dead at the hospital on the same day. To check motorcar for any possible mechanical failure that may have caused or contributed to the accident. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.</p>	<p>SJJ8728K - Driver (Potential Defendant)</p>	Adrian Lim
4	TP/IP/30524/2022	<p>On the 11 November 2022 at about 12.59 a.m., the involved party motorcar was travelling on lane 3 / 4 along Jalan Besar towards Bencoolen Street. The involved party subsequently made a lane change from lane 3 into lane 1 and collided onto the left rear side of a police vehicle; who at the point of time, was travelling straight on lane 1 / 4. The impact caused the police vehicle to surged forward and collided onto a shop house. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.</p> <p>The said car is a Getgo motorcar. There is no ignition key. Once the date is confirm, please update me and I will contact Getgo to get a representative to turn on the vehicle with their application.</p>	<p>SLD962K - Driver (Involved Party)</p>	Farhan Sairi
5 - 6	TP/IP/31296/2022	<p>On 19 Nov 2022 sometime before 28 a.m., the rider was riding his motorcycle along Serangoon Road when he collided onto a police car which was turning out from a kerb side parking lot on the right side of the road. To check police car and motorcycle for any possible mechanical failure that may have caused or contributed to the accident. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.</p>	<p>QX505H - Driver (Involved Party)</p> <p>FBT6793B - Rider (Victim)</p>	Adrian Lim

7 - 8	TP/IP/29690/2022	On 2 November 2022 sometime before 5.25 p.m., the driver of motor car, SND9853J was driving along Kranji Expressway towards Bukit Timah Expressway on lane 1 of 5-lanes road when he suddenly felt an impact from the rear and noticed one motorcycle, FBM221L had collided onto his motor car. The rider of the motorcycle was unconscious and suffered seizures as informed by the paramedic at scene. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play. 9	TP/IP/32554/2022	On 2 December 2022 at about 0620hrs, Involved Party Taxi was travelling along Bishan Street 22 when he collided onto the pedestrian(Deceased), who was crossing the road at the pedestrian crossing from his right to left. Deceased sustained head injuries and was conveyed to TTSH in an unconscious state where he succumbed to his injuries and pass away on the same day. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.	SHA9055H - Driver (Potential Defendant)	Adrian Lim
10	TP/IP/33181/2022	On 7 December 2022 at/or about 6.40 p.m., the driver was driving along Yishun Ave 1 after Yishun St 81 entering into a car park when the vehicle engine sudden shut off, as driver restarted the engine, the vehicle suddenly surged forward, went up the kerb and went down slope along the grass verge and collided onto a small tree. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.	SMQ5937X - Driver (Potential Defendant)	Koh Wei Jie
11	TP/IP/33304/2022	On 8 December 2022 at about 17.05hrs, Involved Party van was reversing at the said location, on the single lane one way road along Berwick Drive when he collided the pedestrian(Deceased), who was crossing the road at the rear of his vehicle from his left to righ. Deceased sustained head injuries and was conveyed to TTSH in an unconscious state where he succumbed to his injuries and pass away on the next day. 12	TP/IP/32687/2022	On 3 December 2022 at about 8.31 p.m., the Deceased was crossing the road at the signalized pedestrian crossing when the Involved Party came from his left to right and collided onto the Deceased's left side. Due to the impact, the Deceased flung forward and landed on lane 2 of 3-lane road. The Deceased was conveyed to National University Hospital (NUH) by ambulance in an unconscious state and pulseless. On the same day, the Deceased succumbed to his injuries and was pronounced dead at 10.05 p.m., by Dr Ang of NUH. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.	SHA3417L - Driver (Involved Party)	Kamaliah
13 - 14	TP/IP/32286/2022	On 11 November 2022 at 2.22 p.m., the Deceased was cycling along Adam Road towards Lornie Road on lane 3 of 4-lane road behind 2 other cyclists in a single file, when the Accused collided onto the rear of the Deceased's bicycle. Due to the impact, the Deceased and his bicycle flung to the left side kerb. After the collision, the Accused did not stop his vehicle and drove off from the scene. The Deceased was conveyed to Tan Tock Seng Hospital (TTSH) by ambulance in an unconscious state. The Deceased then succumbed to his injuries and was pronounced dead on 30 November 2022 at 7.35 a.m., by Dr Benjamin Han. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.	EW14E - Driver (Potential Defendant) Bicycle - Pedal Cyclist (Deceased)	Mariah
15 - 16	TP/IP/32680/2022	On 3 December 2022 at about 2.59 p.m., the Accused was travelling straight along BKE (Woodlands), near to 9 km mark, on lane 1 of the 4-lane road and collided onto the centre guard railings on her right. The Accused then lost control of her vehicle, veered to the left and collided onto the Deceased who was travelling on lane 3. Due to the impact, the Deceased and his motorcycle was thrown to the left and landed on the road shoulder. 	the left guard railings before it veered to the right and came to a stop on lane 2. The Deceased sustained multiple injuries and was pronounced dead onset at 3.12 p.m. by the attending paramedic. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.
