

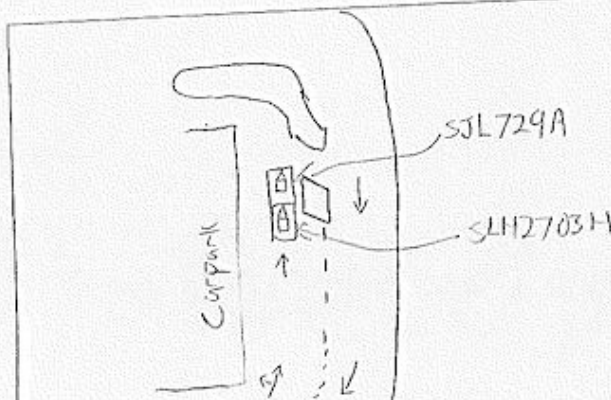



On the 18th Dec 2022, 1622, i drove my white Citroen car, SLH2703H into the Choa Chu Kang swimming complex to fetch my family. There was mild rain but road conditions are visible. Ahead of me was a red Subaru car SJL729A. Whilst on the one way road leading into the swimming pool carpark, the Subaru car came into a abrupt stop where i managed to stop behind it in time. However, the Subaru car reverse light came on, which got me honking it to alert it, but it continued to reverse into my stationary car. The driver (driver Wee Choon Phang (NRIC S8804274C)) and i exchanged particulars, but the driver came across as a very demanding person. Vehicle-Camera. As such, against his wishes of private settlement, I told him I will proceed with insurance claim. He too, challenged me to lodge a police report, which i now do, due to fear of personal safety considering that he has my residential address.

After he departed, where he drove into the carpark against the traffic, I moved on to pick up my family members at the swimming pool complex carpark. Whilst they were alighting my car, the Subaru driver suddenly appeared and started taking photo of us, with a female behind him. My elderly father, Ng Ching Chun, was very taken aback by the intrusion and demanded to know why the intrusion. Both my father and Subaru driver ended up in loud conversation, and that the Subaru driver left the scene cursing at us. I do fear for our safety.
