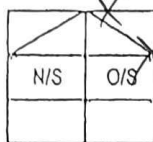

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 18 Jan 2022 around 11am, I was travelling alone within
Balti market toward Tiona Bahru. I was on the second
lane. Suddenly a lorry - GBJ 2541P, on the right first lane
