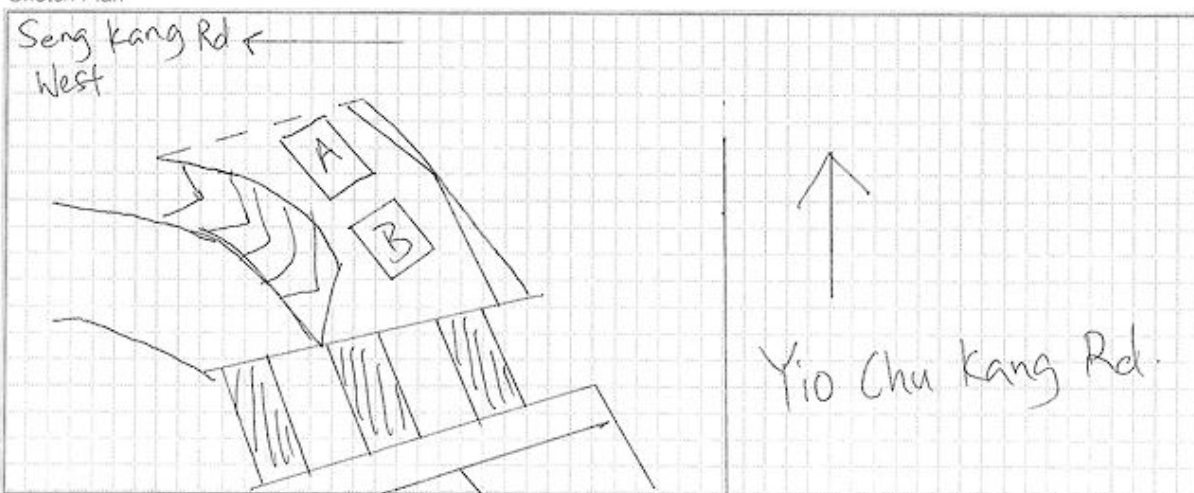

Describe Circumstance of the Accident

On the evening of 20 Dec 2022 at about 7.13pm, I was travelling along Yio Chu Kang road, entering into the slip road towards Seng Kang West road exit.

My vehicle (B, SMN6704K) came to a stop queuing behind vehicle A, Carplate no. SLZ 3473U whom is also queuing behind another vehicles while awaiting for the ^{incoming} traffic to stop before we can move on.

After a short waiting, the traffic was clear for our vehicles to move on. The front vehicles proceeded but vehicle A (SLZ 3473U) suddenly came to a stop in front of me and my vehicle was not able to e-brake in time and bumped into the rear of his vehicle.

The road condition was not dry due to the raining weather.
