Brief facts: 3. On 16/11/2022 at about 7.55pm, the bus driver, had arrived at Enterprise Hub to charge the 23-seater electric vehicle (EV) bearing license plate number PD511G at the charging port station that was contracted by her bus company 'STRIDES' affiliated under SMRT. The driver had maneuvered the EV, headfirst in a manner to connect the charging cable to the EV port. Prior to aligning the EV to the charging port terminal, the defendant noticed the victim was seated on the ground at the narrow alley at an estimated 1.5 meter distance from the front of the EV. However, the driver realized that the charging port was too short to reach the EV charging connection port. Thus, the driver boarded the EV, intending to inch the EV slightly forward instead. The driver did not gesture or signal the victim to move away. The driver stepped on the accelerator abit and was supposed to step the brake however she accidentally stepped the accelerator further causing the EV to move forward and hit onto the victim. Driver managed to stop the bus about 10 meters ahead. The victim was found underneath the bus and was conveyed to hospital.
