
**SKETCH PLAN**

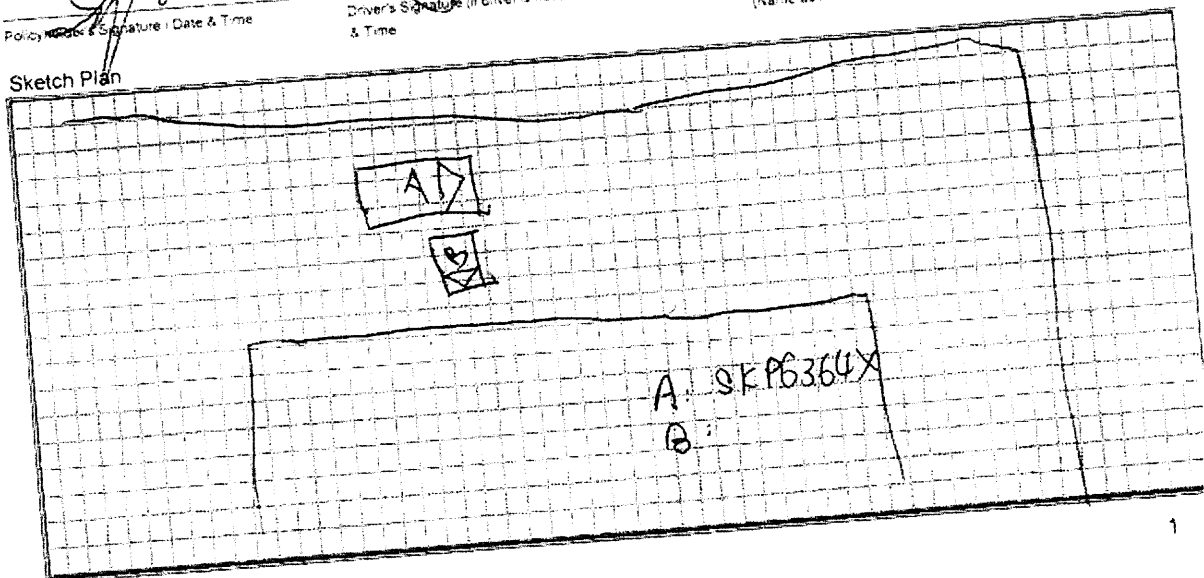
