- 1. The owner of motor vehicle no. GBE4448R hereby authorise Ryder Auto Pte Ltd to commence repairs of the said vehicle forthwith. - 3. If for any reason my/our insurer's are not willing to settle the repair costs either in part or in whole then I/ we undertake to pay Ryder Auto Pte Ltd the repair cost.
