CIRCUMSTANCES OF ACCIDENT

R2000009630 Circumstances Of Accident There was heavy traffic at that time and lanes were overcrowded with indiscernible lanes (4-5cars crammed into 3 lanes) on the other road that was merging with the road our car (A) was on. Cars on our road were still clearly following the 2 lanes. We were following pretty closely with the car in front of us but at the merging point of the two roads

the other car (B) cut into our lane (as we maintained a bit of safety distance) while failing to signal and additionally was crossed over multiple lanes when changing lanes as the moving pace was slow and there was minimal space to navigate. As B did not signal while cutting in

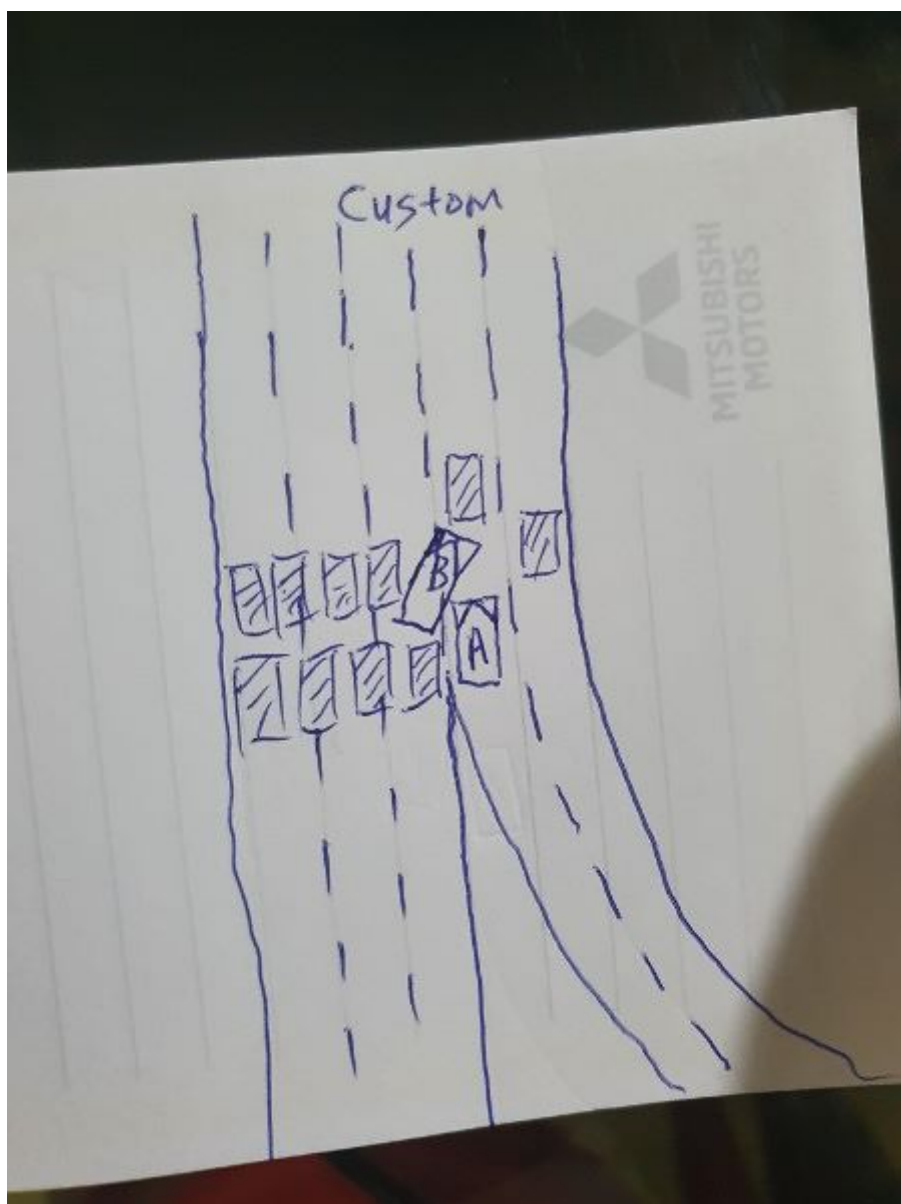
we had to brake and turn slightly to the right in order to avoid collision. Between the motion of both cars
