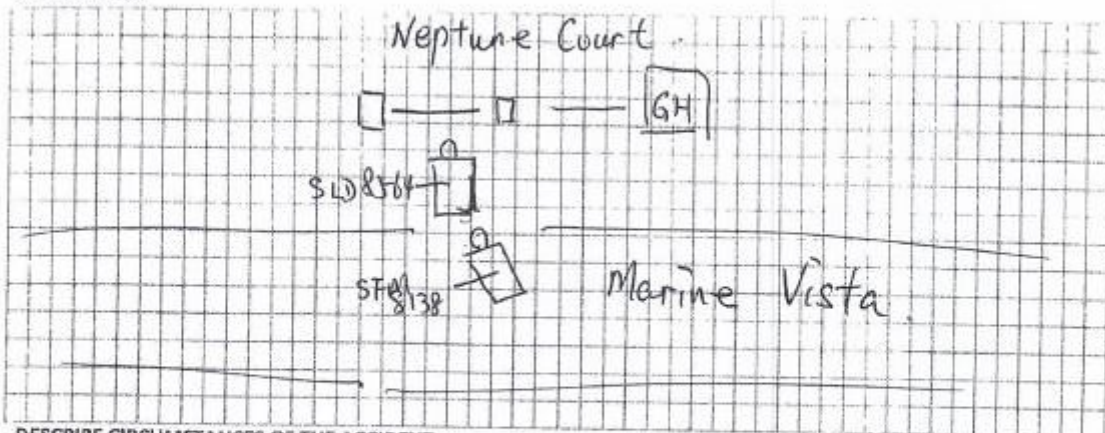

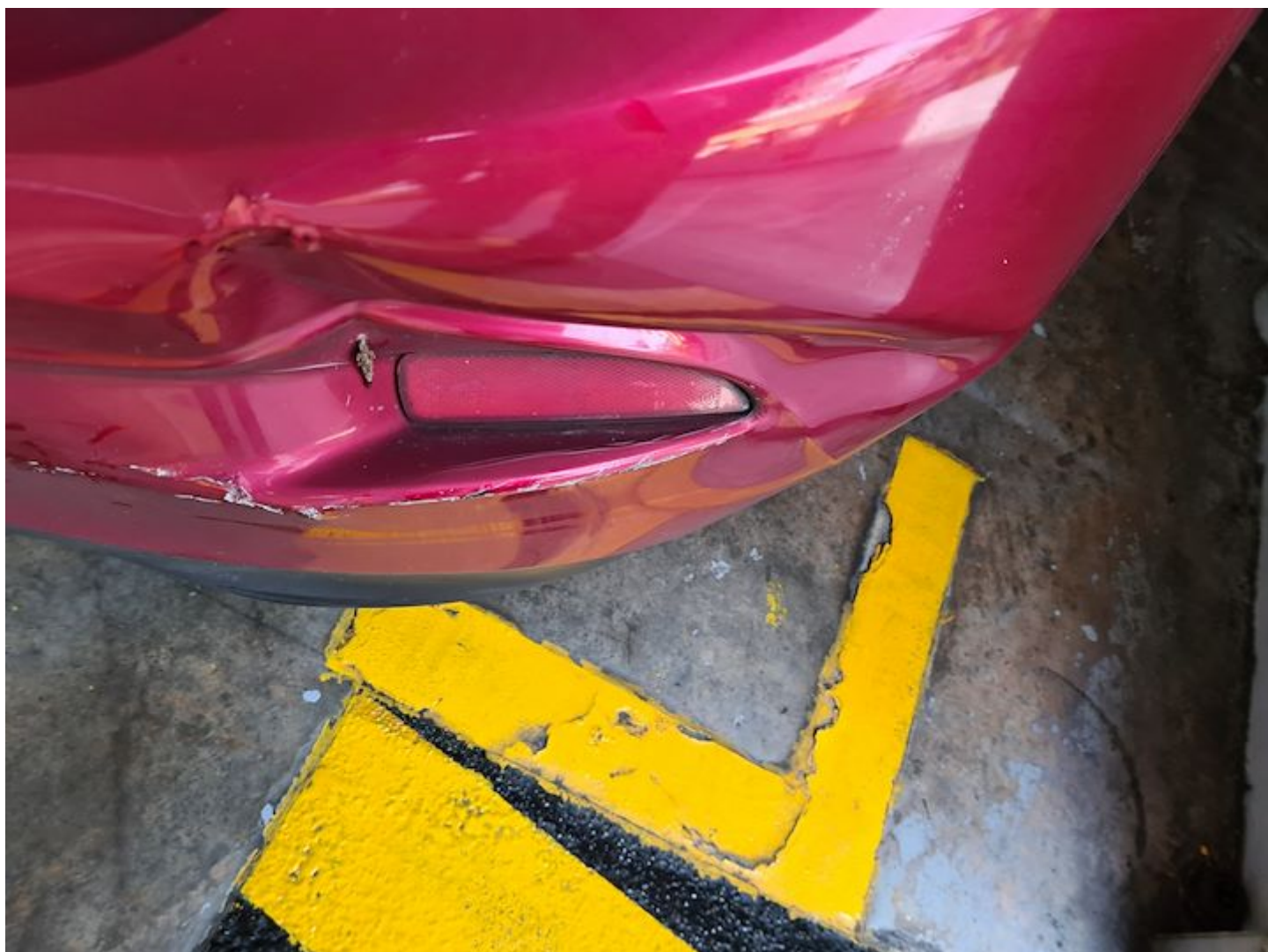


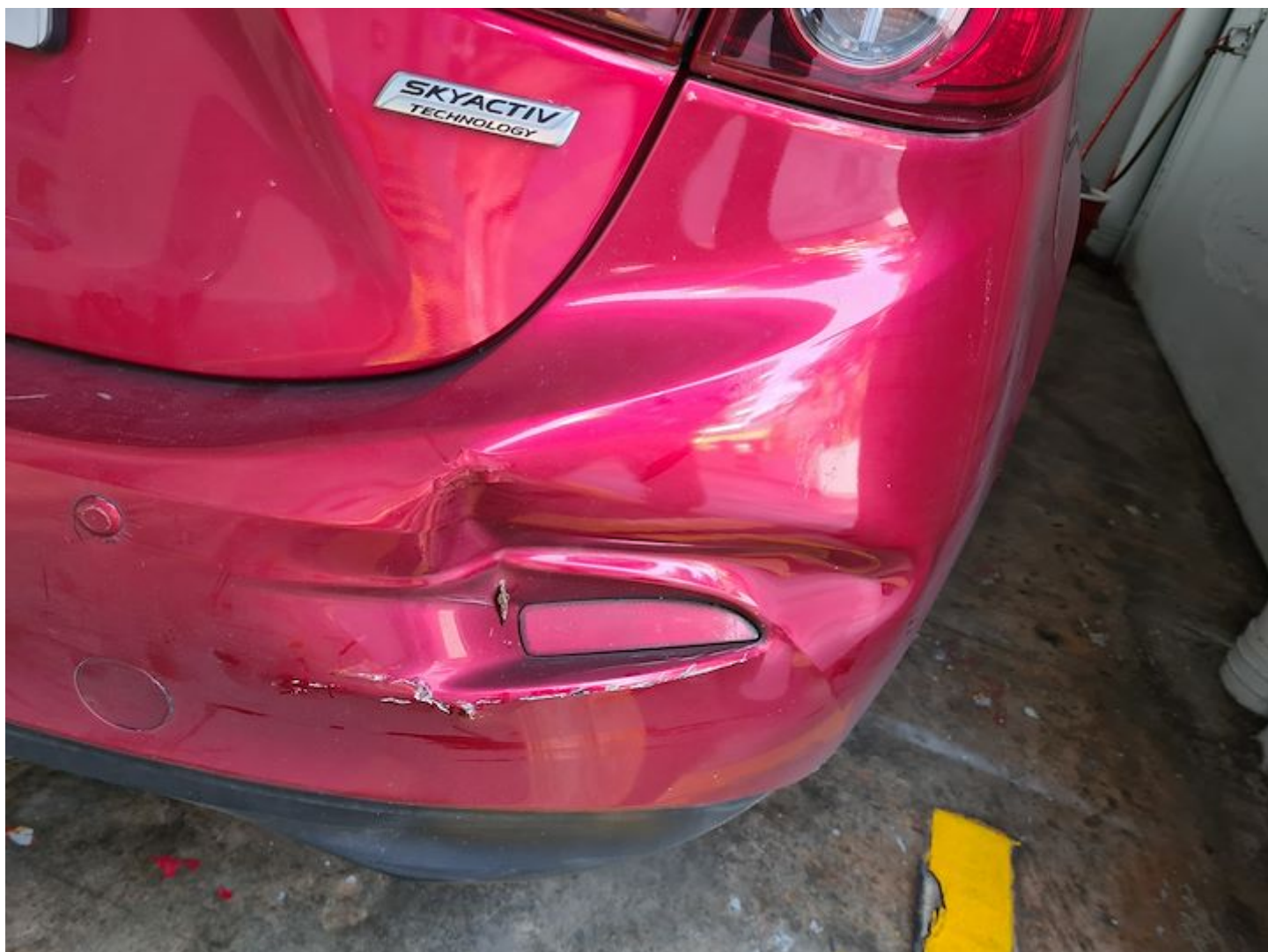































ACCIDENT REPORT 31 DEC 2022

I was driving vehicle registration no. SLD8564 northwards along Marine Vista and made a right hand turn into the outer (right hand) of two entry lanes into Neptune Court, 4 Marina Vista, at 9:45 PM. I stopped at the security barrier at the guardhouse. I realised that the outer entry lane was for 'residents only' and that I needed to enter via the adjacent left hand lane. I put the car in reverse gear, looked in the rear view mirror, and reversed slowly. Unfortunately, at that point a car driven by Mr Tan, vehicle registration no. SFM 8138U entered the lane having also turned right from Marina Vista into the lane. The two cars collided at slow speed. Both drivers stopped and got out of the car to exchange details and inspect the cars. There was very minimal damage to Mr Tan's car which comprised only a dent to the front number plate. There appeared to be no other damage by physical and visual inspection of the front of the car behind the number plate. The damage to the SLD8564 was confirmed to the lower right hand side of the rear bumper which had a small compression dent around the light reflector.
