**Brief Details.**

On 27.12.2022 at about 1330hrs, I was driving my Malaysia registered vehicle, BGT6034 (Toyota) along Clementi Ave 6 towards PIE (Tuas) at the center lane of three lane road. At that time the weather is clear, and the road surface is dry. I was proceeding to Choa Chu Kang for my painting job.

Along the journey at the traffic junction of Clementi Loop, traffic light turned red, and I slowed down my vehicle. Out of sudden, I felt collusion from the rear. I came out from my vehicle and discovered that Singapore registered vehicle, GBK3348X collided into my vehicle.

We decided to move into Clementi Loop to avoid traffic jammed and to assess the accident. As we did not suffer any serious injury, we exchange our contact details and continue our journey. While I was turning into Clementi Loop, the traffic light camera flashed a few times.

At about 1430hrs, I went to Central 24-hr Clinic (Clementi) as I felt some pain at the back of my neck. The doctor assessed my injury however I did not suffer any serious injury. The doctor then issued me with 3 days of Medical Leave.

I wish to state that this is the first time it happened to me and there is no in-car installed inside my vehicle.
