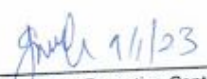
I was travelling along Jalan Bahar exit, As the front vehicle suddenly jam brake. I wasn't able to stop in time and collided.

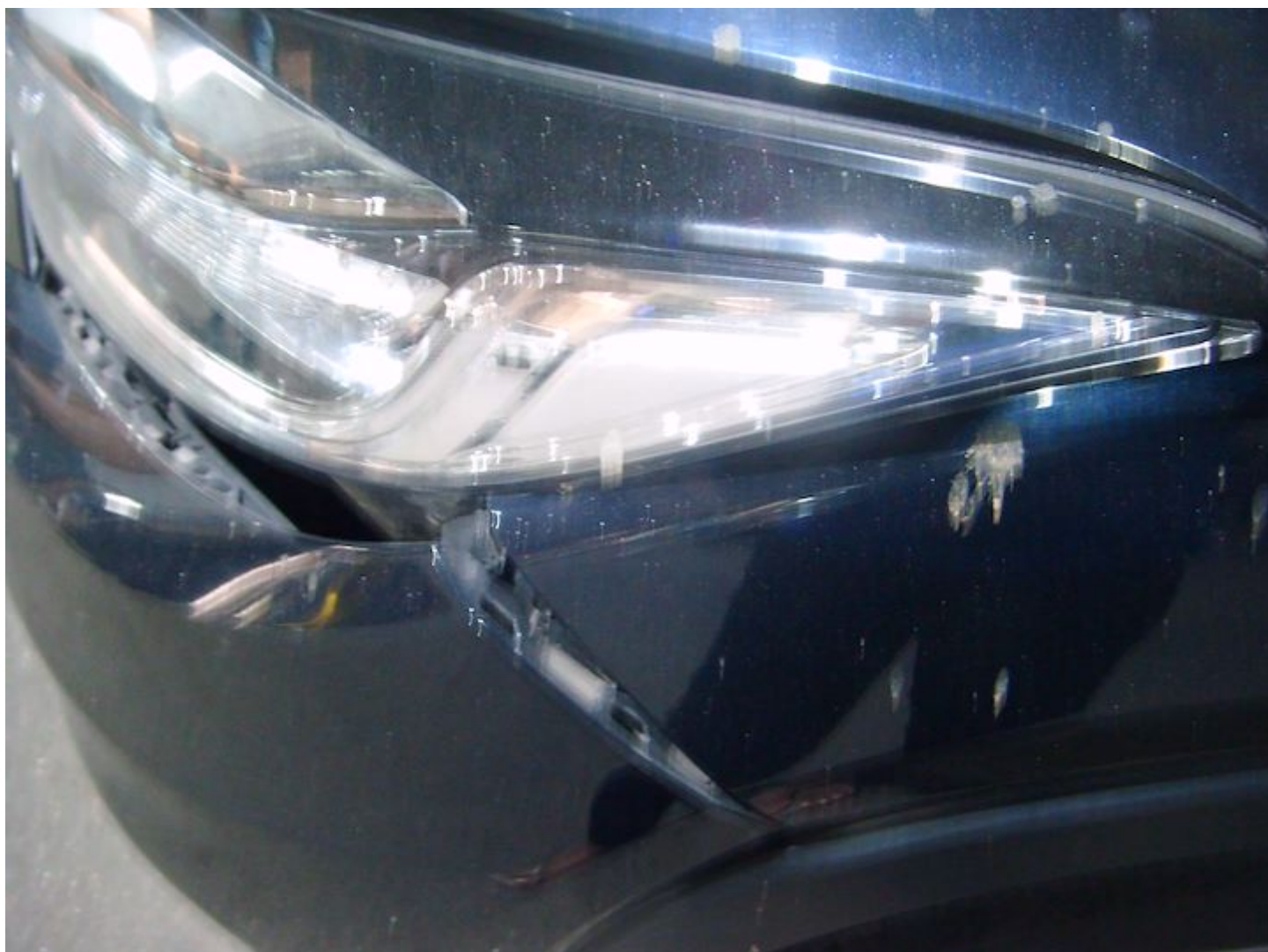




















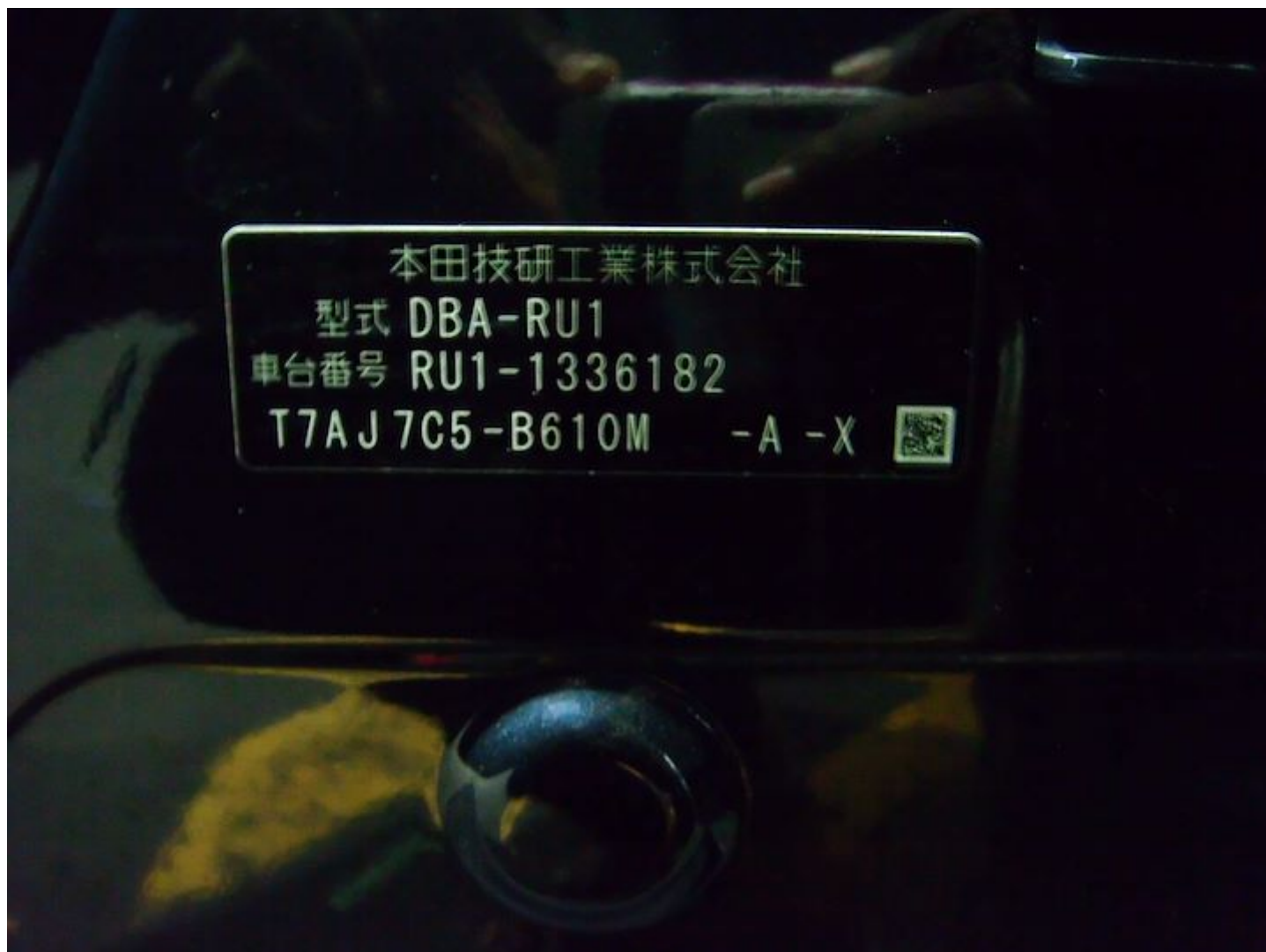
