

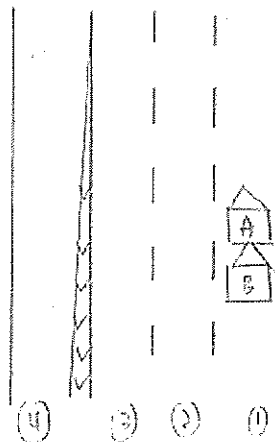

Vehicle (B) = 68H 9608 H


TPE towards Upper Changi Road
East (before Elias Road Exit 4)


