

Brief Details.

On 10/01/2023 @22:10hrs, my employee was driving my bus PD171D along Jalan Toa Payoh (opposite woodsville close) on the left lane of 2 lanes. As there is road works ahead of my lane, he on his right signal to show his intention to switch lane to avoid the road works and after checking the right lane is clear to switch, he proceed to switch lane with caution and as my bus was almost completing the lane switch, a Mini Cooper car SLT4000B drove at a fast speed up ahead and attempt to squeeze in between the space between my bus and the road kerb and then accident happened. After the accident, my bus was stationary and my employee was preparing to get off my bus to exchange particulars with the car driver but instead of stopping the Mini Cooper driver accelerated the car and drove off and hit my bus a 2nd time causing futher damages to my bus. The Mini Cooper driver did not stop at all after both impacts and i am making a police report for this hit n run case after I have managed to retrieve the car plate number from my bus cctv.
