Brief Details.

On 10/01/2023 at 1743hrs, I was riding my motorcycle JRS1095 along Adam Road toward Farrer Road at Lamppost 53. I was on the rightmost lane travelling behind another motorcycle when a vehicle (SFX5454T) suddenly made a right turn and hit onto the motorcycle (FBL7900U) which was in front of me which causes the motorcycle to skid and I could not brake in time and I collided into the motorcycle which causes me to flunk toward the front. I subsequently got up and walked to the side of the road and I called my manager. Subsequently, the traffic police and ambulances arrived, and the ambulances made a check on everybody and conveyed the other rider of FBL7900U. My manager managed to get the video from the owner of SFX5454T.

I went to see a doctor at UniHealth 24-hr Clinic (Toa Payoh) and they gave me a 3 day mc.

There were to other vehicle involved in the accident which are SMR977H and YQ7187M.
