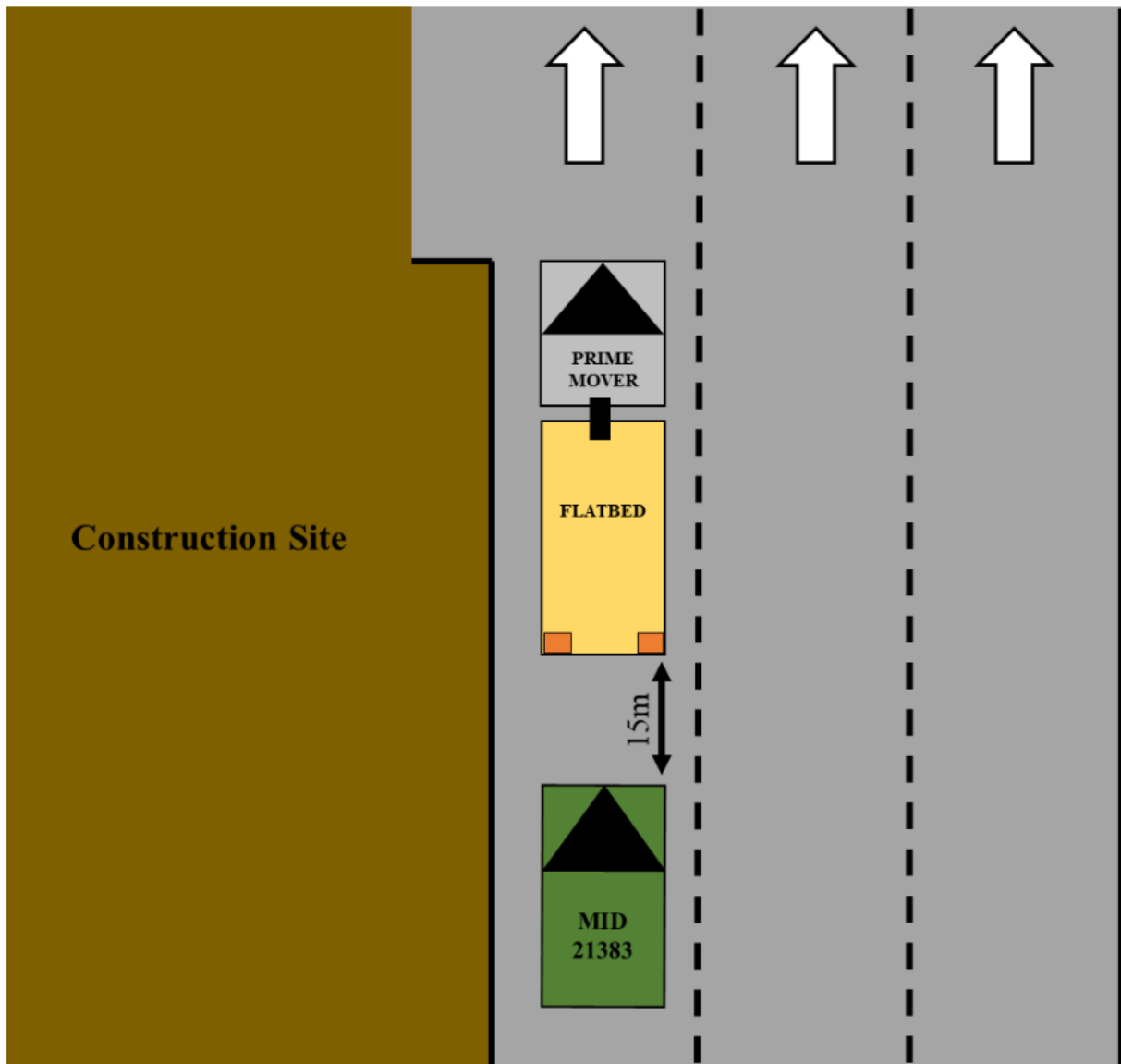


Figure 1A: Schematic Diagram

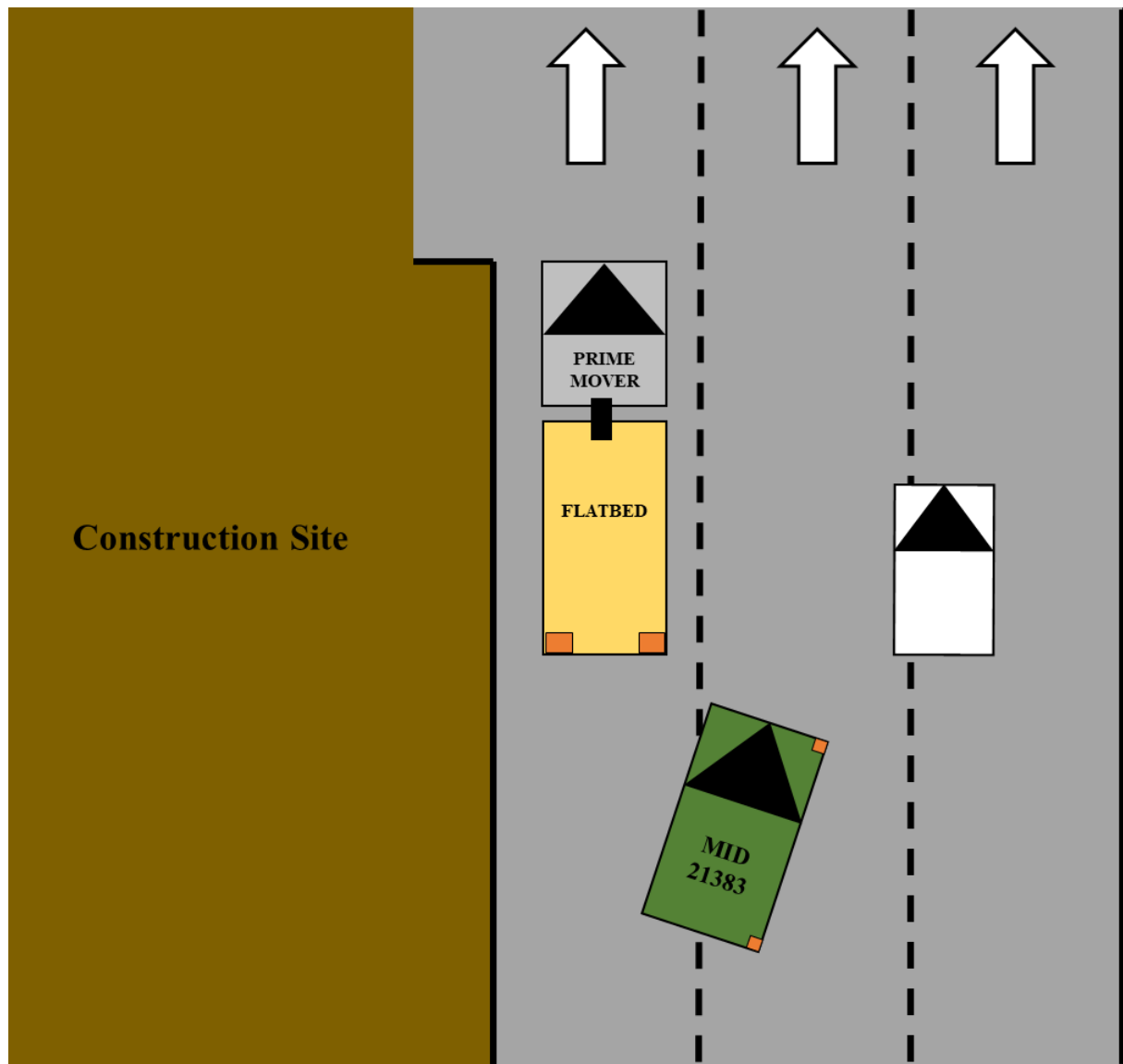


Figure 1B: Schematic Diagram

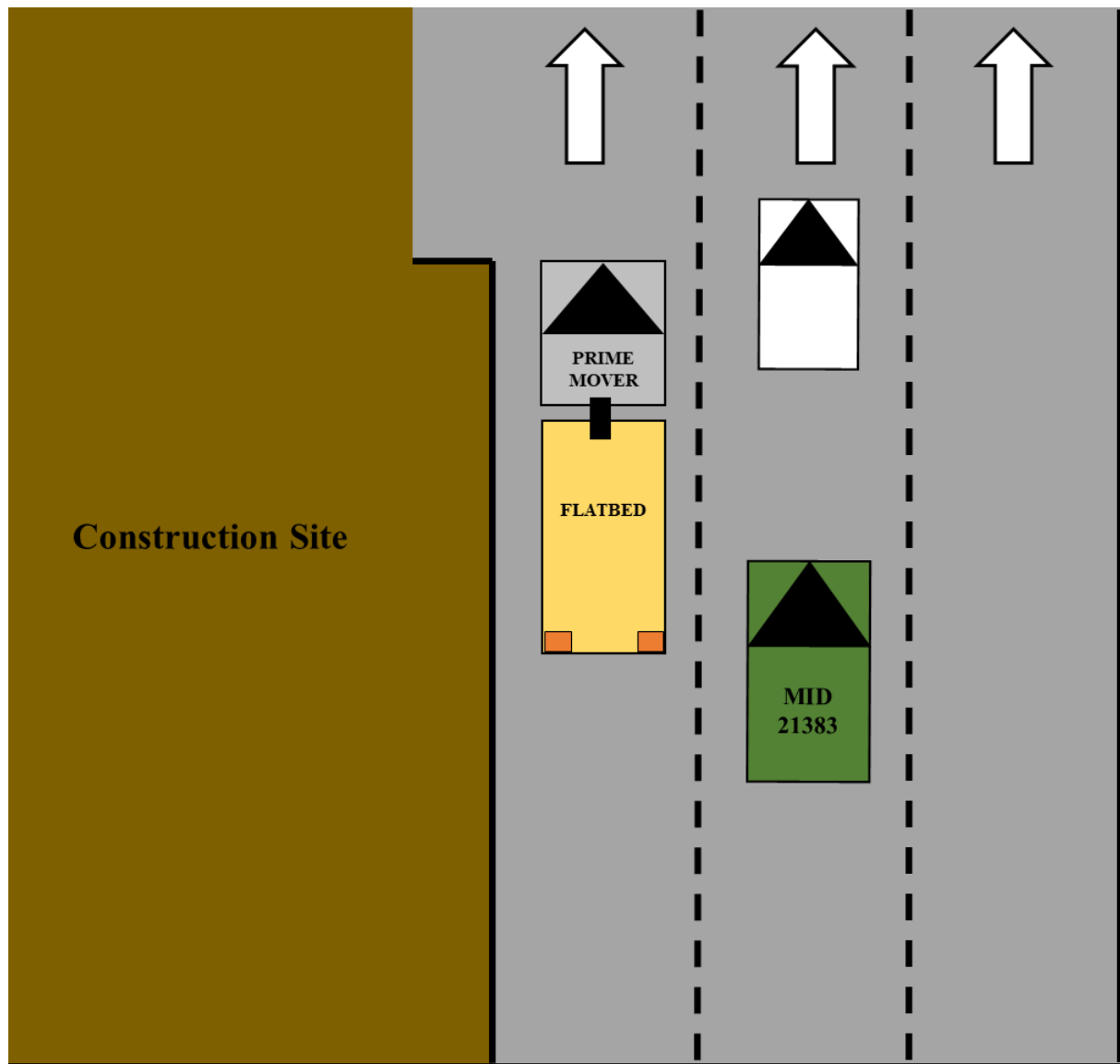


Figure 1C: Schematic Diagram

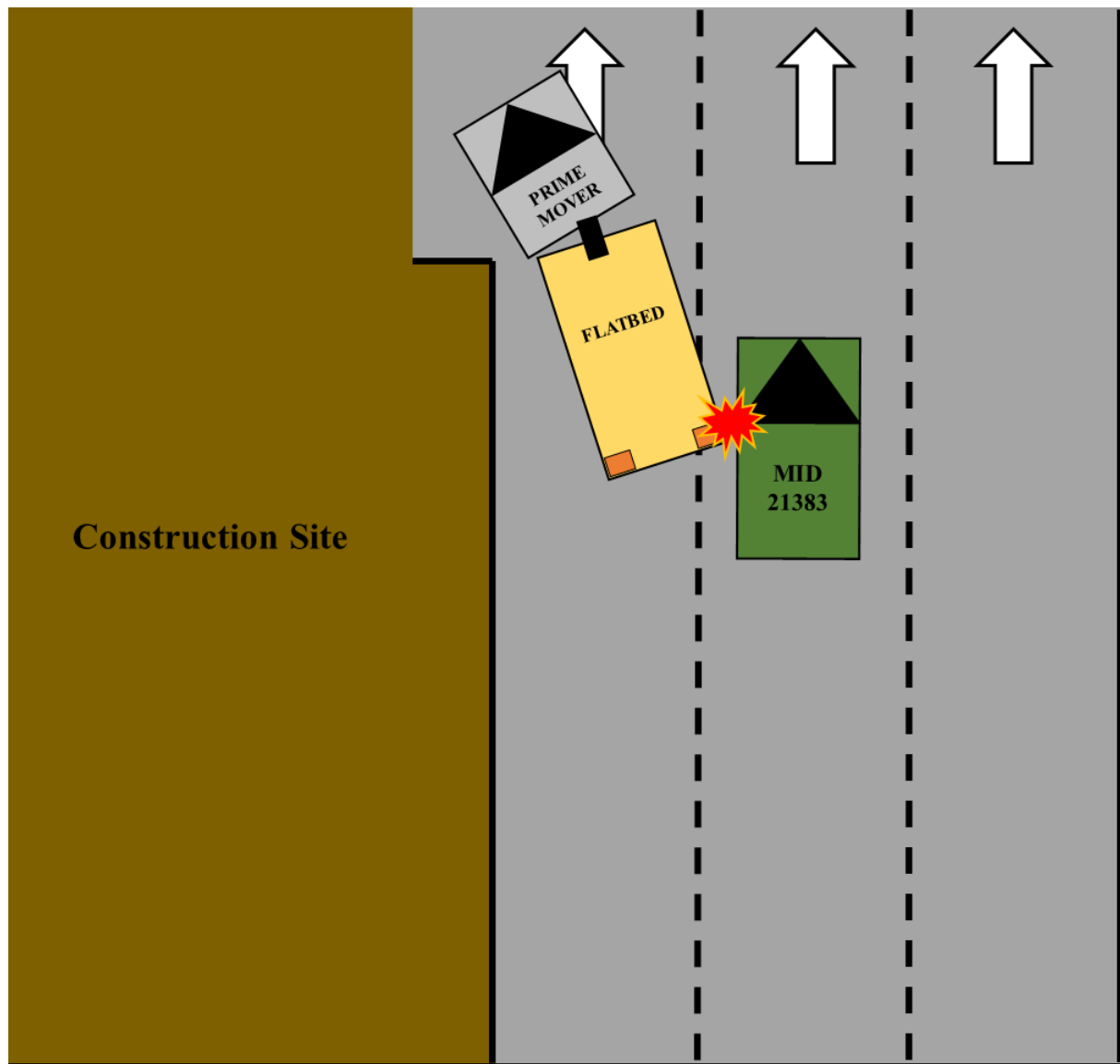


Figure 1D: Schematic Diagram

<p>I, TXXXXX016B, PTE MOHD SYAHMI BIN MOHD ISMAIL, am writing this statement to describe the incident that has happened to vehicle number MID 21383 at 1022 [REDACTED]</p> <p>[REDACTED] This incident happened at Mandai Road as I was driving on the 3rd lane, ahead of me was a civilian trailer signalling hazard lights so I stopped behind. The civilian trailer did not move for about 1 minute, so I started to signal right to overtake the trailer, because the trailer was not moving for a long time. I told my vc and the front passenger I was going to overtake the trailer. I signalled right for a while, waiting for clearance. Once clear, I started overtaking the trailer when suddenly on my right I saw a white van going very fast on lane 2. It was a bend so I did not see the vehicle at first. I was focused on the white van when changing lanes. I did not see that the trailer started to turn left. The trailer had hazard lights on and started turning when I already fully changed lane and was parallel to the trailer. The back of the trailer protruded into my lane and grazed the left side of my vehicle. My VC and front passenger went down to check the situation and guided the 5 ton to the side of the road.</p>

to Pasir Laba Camp. On the same day at about 1020hrs, while I was driving the said vehicle along Mandai Rd at the extreme left lane, I spotted from a distance that there was a trailer stopping at the side of the road with its hazard light on. I began to slow down the vehicle and stopped behind the trailer bearing registration no: XD433H / TRD 1374. At the point of time, I am not sure onto why the trailer on its hazard light. I decided to overtake the trailer as I waited quite a while and the trailer did not move. I began to signal right to inform other road users that I am overtaking the said vehicle.

While I was about to overtake the trailer, I saw an oncoming vehicle was on the 2nd lane however, the vehicle gave way to me and went to the 1st lane. I then moved off to overtake the trailer. Out of the sudden, the trailer just turned left into the construction site and I was unable to react on time, thus the back of the trailer hit the left side of my 5 tonnes truck.

I then turned off the ignition and got out from the truck. I managed to speak to the driver of the said trailer. I informed my Duty Sgt, 3rd SGT Muhaimin about the matter and he informed me that he acknowledged the incident and will bring up the matter to the SAF Management. On the same day at about 1100hrs, my supervisors namely: 2nd LTA Rex, 3rd WO Nilkanth and SSGT Benny came to the scene and assessed the situation. They managed to speak to the supervisor and extract the IVC camera from my truck. 3rd WO Nilkanth informed me that I will follow them back to Pasir Laba Camp in another vehicle while SSGT Benny will take over my 5 tonnes truck.

The purpose of me lodging this report is for solely for SAF Internal Investigation and record purpose. I will also like to state that there is no one was injured, no involvement on pedestrian or cyclist and no one being conveyed by ambulance.
