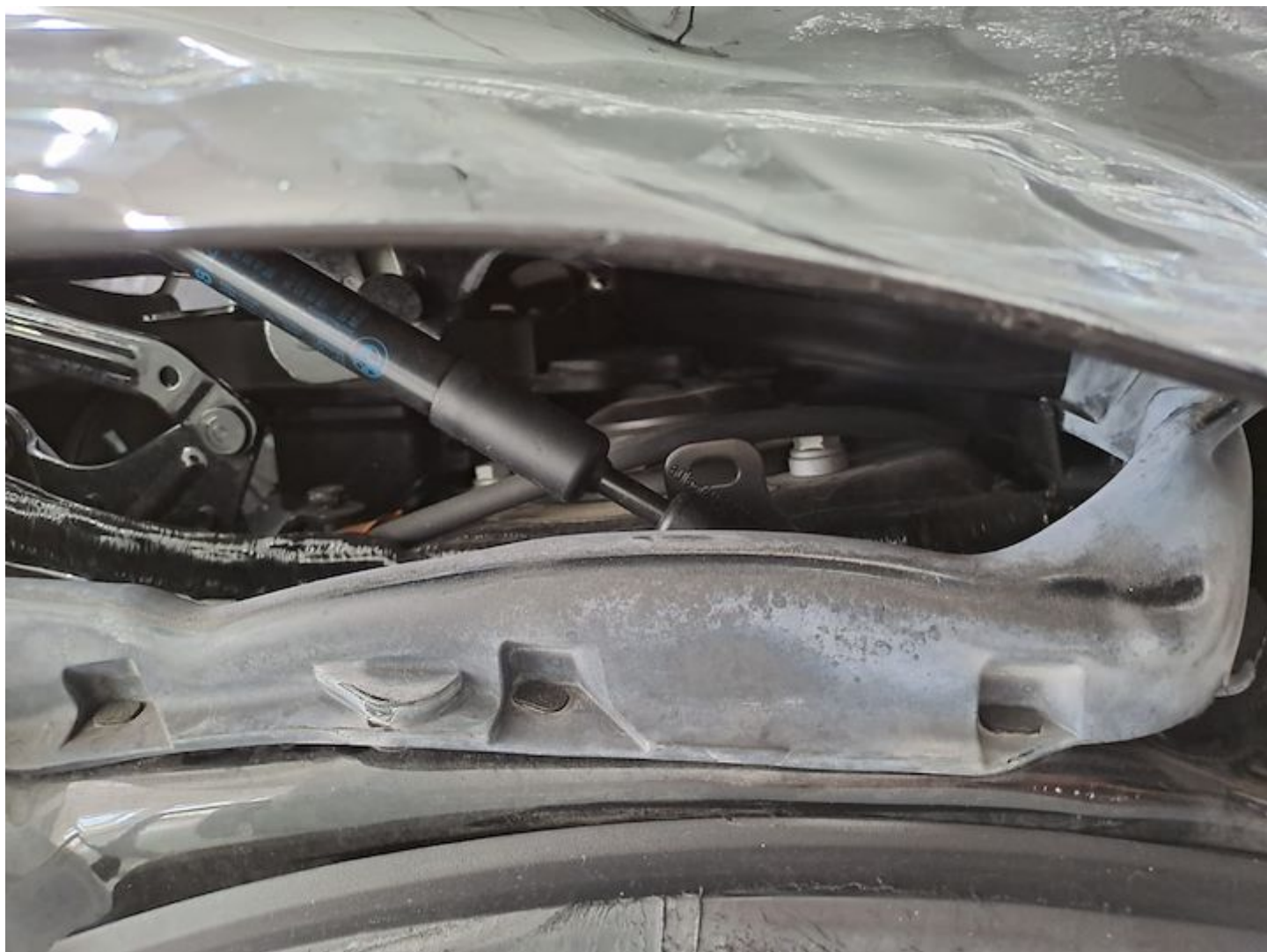




































































































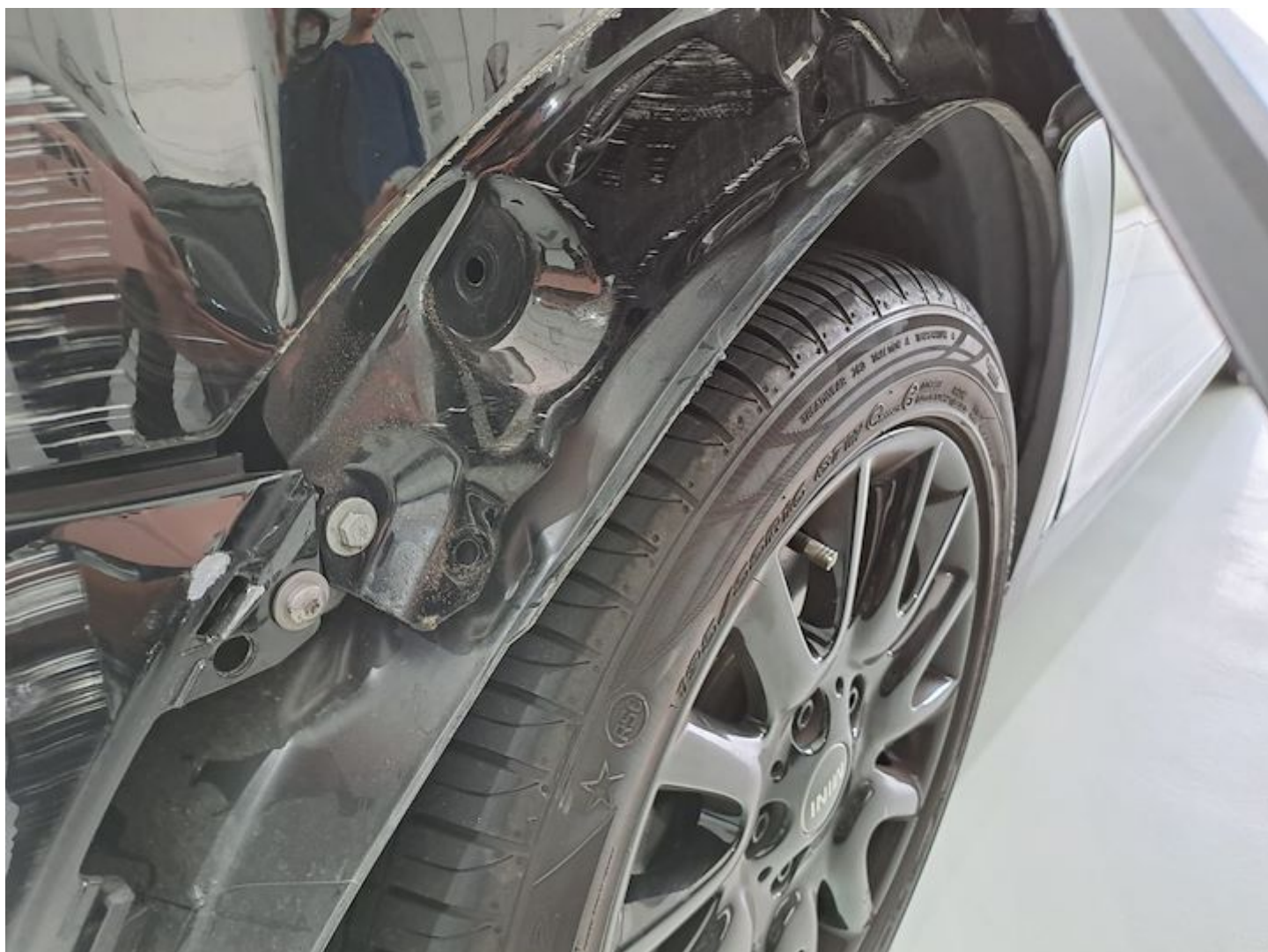


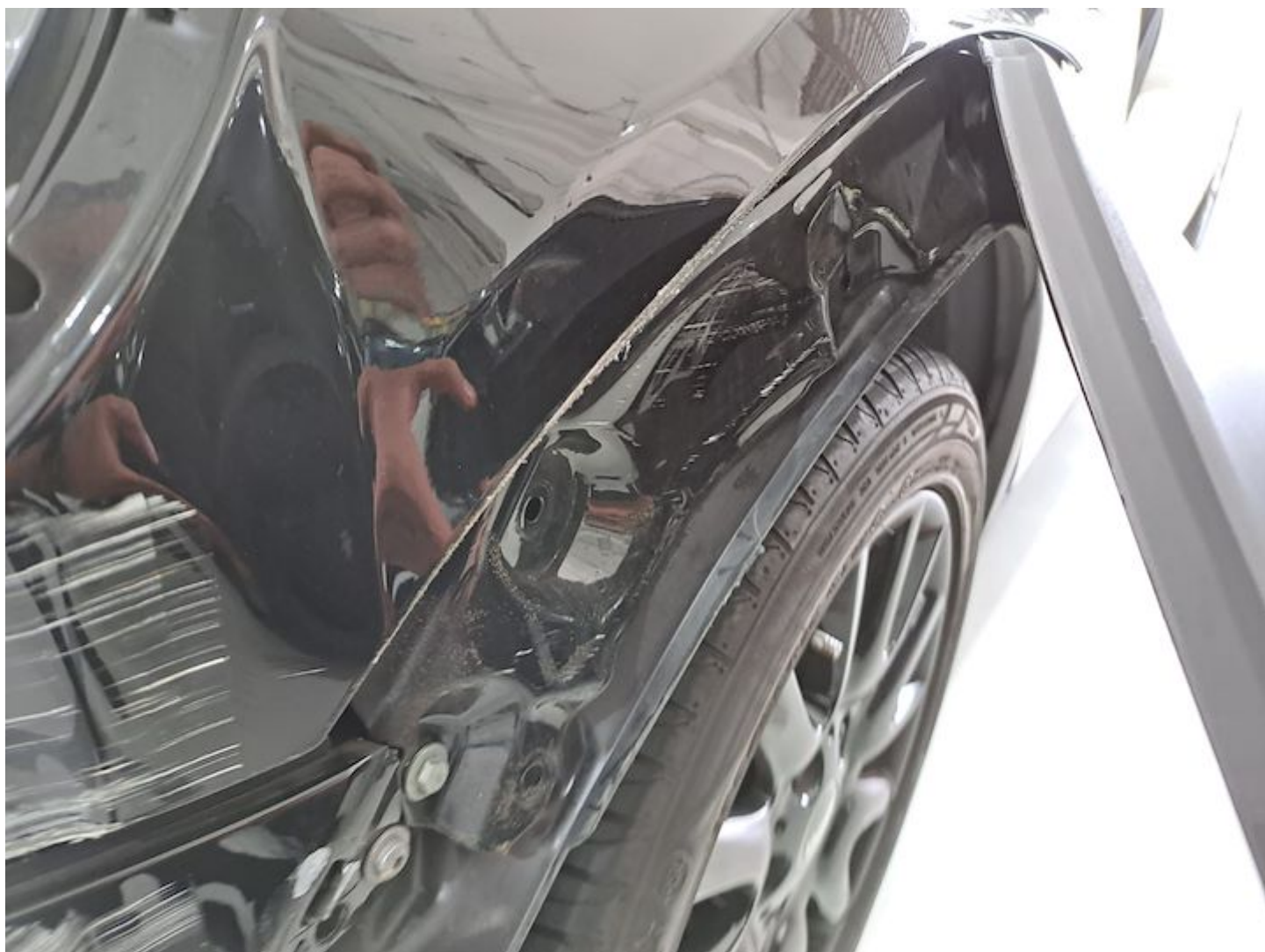

Brief Details.

At around 540pm on 10 Jan 2023, I was driving my car (SMR977H) along Adam Road heading towards Farrer Road. My friend, Lucas Chia Bo Yi, was sitting next to me in the passenger seat.

I was on the 2nd lane from the left, traveling behind a grey lorry (YQ7187M). I put on my signal light to filter right, and after checking my blind spot to ensure that the lane was clear, I began moving out to the right lane.

I was midway through executing my lane change when a brown Subaru Forester (SFX5454T) came at a substantial speed from behind and collided with me at my side of the car. The impact then caused my car to slam against the grey lorry (YQ7187M) on my passenger's side.

The brown Subaru Forester (SFX5454T) went on to hit 2 other motorcyclists (FBL7900U & JRS1095) that were on the road in front of it before coming to a stop.

The SD card of my dash cam was taken by the traffic police officer for further investigations by the IO.
