 not on the night of incident . the stationary vehicle is still parked illegally. He had difficulty exiting out due to the inclined sharp edge of
 the ramp
 the parked car on the left and the narrow space due to the illegal parked vehicle. As he came out
 turning right
 as it was at night
 my vehicle scratched against the right side of the illegally parked vehicle. As the owner
 i returned from overseas on 17 Jan late night. 18 Jan
 I rested. 19 Jan
 today
 I was informed of the accident
 and immediately i am making the report now.
