LEASING AGREEMENT (TERMS & CONDITION)

- 1. The vehicle is restricted to Singapore use only. In the event the hirer wished to enter Malaysia, he/she shall prior to entering Malaysia inform JACK CARS LEASING & RENTAL PTE LTD & sign up for the appropriate insurance & shall be liable to the terms & conditions set out by JACK CARS LEASING & RENTAL PTE LTD.
- 2. Hirer's Responsibilities:
 - a) The Hirer shall be responsible to pay for the first \$3,000 to \$10,000 damages or cost of repair for each & every accident the Hirer is involved in with the vehicle.
 - b) The Hirer shall be responsible for any loss of earnings by JACK CARS LEASING & RENTAL PTE LTD for the duration the damaged vehicle is undergoing repair.
 - c) The Hirer should note that the Insurance Policy covers only claims from 3rd Parties.
 - d) The Hirer shall be liable for all claims and/or damages arising from the use of the vehicle involving any illegal activity, driving whilst under the influence of alcohol or any other immoral or illegal activity that is not covered by the motor insurance policy taken by JACK CARS LEASING & RENTAL PTE LTD.
 - e) The Hirer shall bear all liability if it is found that he/she had hired the vehicle through fraud, or impostering or sub-leasing.
 - f) The Hirer shall bear all costs incurred in case of a breakdown for all the parts that are not covered under the Insurance wear & tear, Eg.Flat battery or flat tyre.
 - g) There shall be no replacement of a vehicle in the event of a breakdown.
 - h) There should not be any sub-leasing of the vehicle to anyone during the rental as long as the vehicle is rented from JACK CARS LEASING & RENTAL PTE LTD.
 If the Hirer is found sub-leasing the vehicle to another person during the rental, the Hirer shall bear full responsibility for all claims and/or damages arising from use of the vehicle involving any illegal activity.
- 3. The Hirer shall bear all ERP charges, parking fees & traffic fines.

The Hirer shall bear responsibility in the event a traffic offence is committed whilst the vehicle is on hire.

- 4. Any traffic fines & parking charges or any other fees paid on behalf of the Hirer by JACK CARS LEASING & RENTAL PTE LTD will have a surcharge of \$30 as a service charge & be claimable from the Hirer.
- 5. Extension of Leasing Period:
 - a) The Hirer has to give one day's notice prior to the extension of the leasing period & must first sign the extension form.
 - b) Extension of lease is subject to the availability of the vehicle.
- 6. A surcharge of \$30 per hour shall be levied on any vehicle returned after the stipulated returning time.
- 7. JACK CARS LEASING & RENTAL PTE LTD shall not be responsible for any injuries, loss of life or damage of any kind to any person or thing involving the vehicle during the term of the lease. The Hirer alone shall be responsible for all such events.
- 8. The Hirer admits or has sought parental consent before renting the car from JACK CARS LEASING & RENTAL PTE LTD should he/she be below 21 years of age.
