#### Brief Details.

At about 8.30 am, we were on Dunearn Road heading towards the city. As we reached Dunearn Underpass, the traffic light at the junction of Farrer Road turned red, so we stopped at the traffic light. Our car was the 1st nearest the traffic light and on the left most lane as we were heading straight ahead towards the city.

When the traffic light switched to green, we took about a few seconds to start moving again. As we reached the junction of Dunearn Underpass and Adam Road, suddenly an Audi Quattro SUV was speeding towards our left side on the right most lane of Adam Road. I jammed the brakes but our car skidded forward and hit the car's passenger door on the driver's side and came to a stop. Our Airbag didn't deploy. The Audi Quattro spun 90 degrees on its front wheel on impact and came to a stop with its driver side facing oncoming car (Adam Road) right most lane.

A motorcyclist (Foreign Vehicle JTY2055) on our right side fell on his side to avoid colliding with the Audi Quattro.

I exit our car to check on the motorcyclist if he was injured and need medical assistance. He was in pain and sustained injuries on his arm and bleeding on his foot. He commented to me that the Audi Quattro should not have moved.

I then went to the Audi Quattro car and open its door to ask the driver if she was ok and needed medical assistance. She replied that she was ok and told me that she was looking for her handphone and could not find it. I saw the car's Airbag was deployed. So, I left her and asked my wife to call an ambulance for the motorcyclist.

Later, we were approached by a car owner who was right behind us at the traffic light stop earlier, her name is Rachel and her contact no. is 9296 4966. She witnessed the accident and had volunteered to be a witness if needed by the investigation officer.


