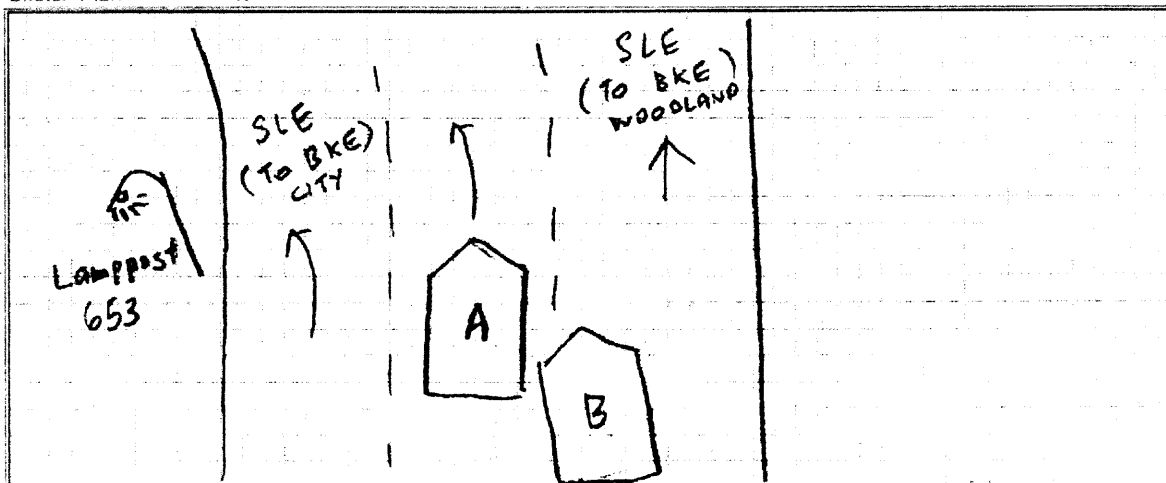

THE SAID CAR SHOWN IN THE SKETCH PLAN AS 'B' (SK26811U) CUT INTO MY LANE FORCEFULLY AND DANGEROUSLY DESPITE THAT HE (MALE MALAY DRIVER) WAS DRIVING ON THE MOST EXTREME RIGHT LANE TOWARDS BKE WOODLANDS DIRECTION EVEN WHEN I HONKED AT HIM CONTINUOUSLY.
