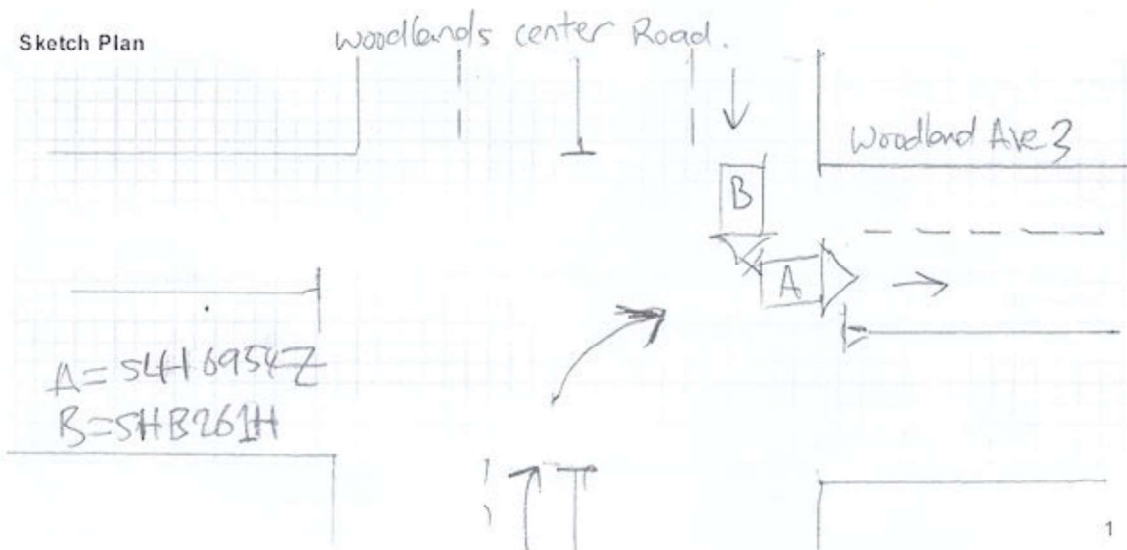

Describe Circumstance of the Accident

I was traveling on woodlands centre road towards Woodlands AVE3. I was on the cross junction going for a right turn. As I slowly inches towards the right to check for car. I see no car and made a right turn. As I was turning out. I see a taxi vehicle driving at high speed ^{without stopping} towards me, it was too late to react. The crash damages the left side of my car from front door to the fender. After the crash, I came out of the car to inspect the damages and look for the driver, but the driver seems to have left the vicinity. I waited for a while more and after a few minutes, I drove off to prevent the blockage of the road and made a police report after. After I review the video footage, I find it unusual that the driver still made a right signal when he is on the left outer lane. And the fact that he just hit and run before exchanging information is a little questionable.

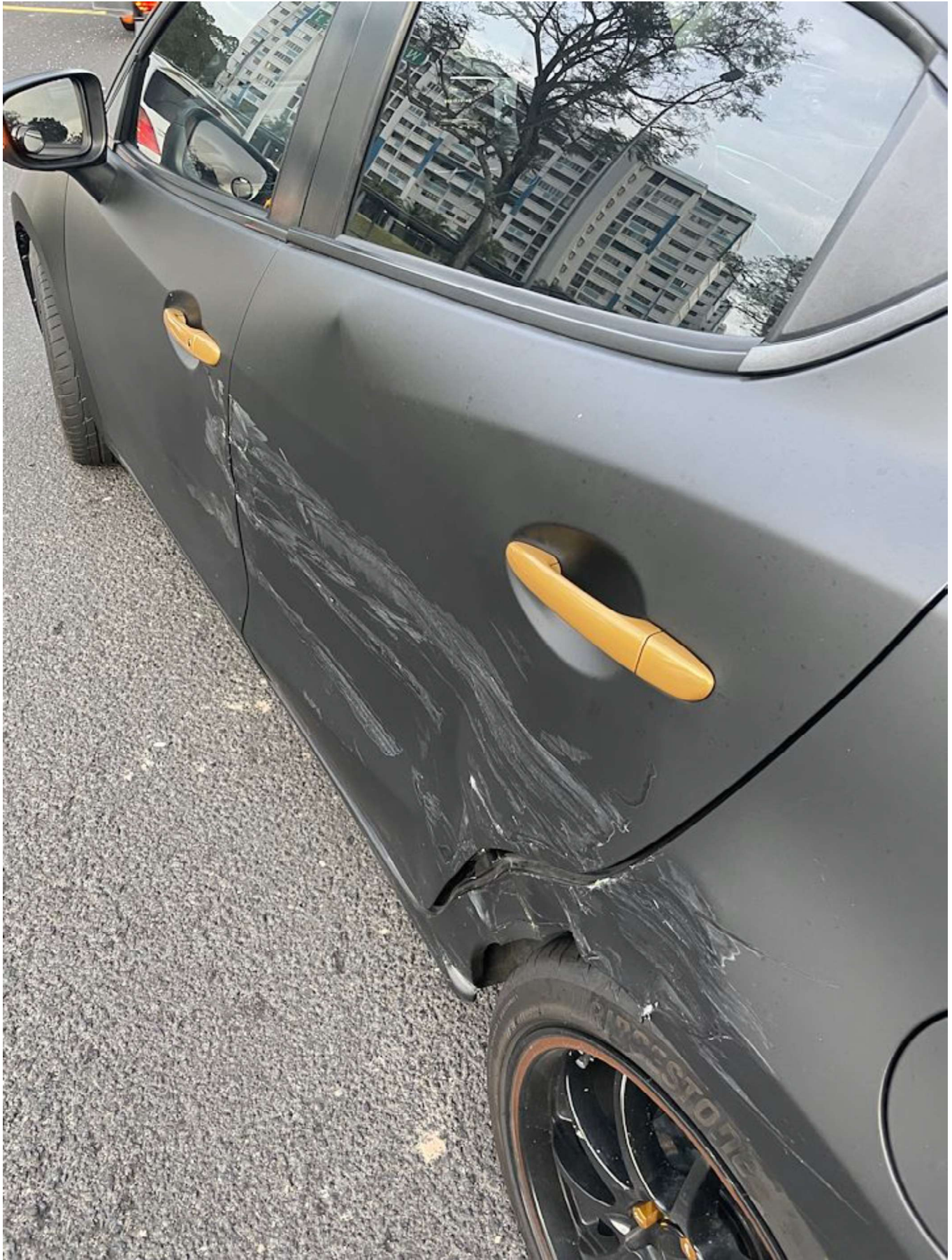
