DIAGNOSIS: Abrasions (minor)/Left shoulder tenderness

The above patient MOHAMED NOR ASRAFF BIN (MOHAMED) was seen by myself in the Emergency Department, Tan Tock Seng Hospital on 11/06/202 at 14:20 hours. He was a motorcyclist, who claimed that he was knocked into a moving car. The patient claimed that a car was filtering into the main lane from the side lane and he subsequently knocked into the back of the car. He subsequently fell to the side of the road, landed on the left shoulder; left chest and left knee. He said that the accident occurred on the same day at 12:30 hours. He complained of pain on the left shoulder; left hip and right ankle with worsen with palpation and movement of shoulder. The patient denied head injury and loss of consciousness and had no nausea, vomiting or headache or dizziness prior.

On examination, the following were noted:

- (1). Mild tenderness over the left anterior superior iliac supine (ASIS) body prominence with multiple minor abrasion over the left shoulder and knee.
- (2). Left shoulder range of motion (ROM) abduction to 90 degrees max limited by pain. Adduction 30 degree: internal rotation 90 degrees; External rotation 10 degrees limited by pain.
- (3). Neck was supple, no tenderness over course of neck, no step off deformity felt on the neck.
- (4). No tenderness over the back, clavicle palpated full length non-tender, no step off deformity noted.

 (5). No pain in pelvic region and ROM of kness bilatorally 0, 120 miles in Other Company.
- (5). No pain in pelvic region and ROM of knees bilaterally 0-120 nil pain. Otherwise no obvious foreign body (FB) seen in any part of the body or open wounds.
- (6). Left knee minor abrasion measuring 1.5 x1.5cm on the lateral side.
- (7). Right ankle small abrasion measuring 0.5x 0.5cm.

X-ray of shoulder Left (AP+LATERAL) was done and reported tom have no fracture or glenohumeral dislocation is detected. The acromicclavicular joint is intact.

Impression was injuries in a road traffic accident complicated by blunt injury with minor abrasion with left shoulder tenderness likely secondary to abrasions.
