

On 27/12/2022 at about 4.30pm. I was driving my vehicle bearing the registration number SNG893L along Selegie Road towards Serangoon Road. I was driving on the most right lane and beside my tane was a van bearing the vehicle registration number GBL 7090G. As I drive forward to the yellow box which is a merging tane, the van collided with my vehicle. I wish to state that I did not notice the van and the van was not in his tane. After the collision, I got out of my vehicle to speak to the driver. He refused to provide his particulars and told us to report to our insurance company. I managed to take some photos of the scene before he drove off. I then called the Police and the Traffic Pelice came to scene subsequently. I was then given a case card to lodge an accident report. Other than myself, there were two other passengers in my vehicle. The 3 of us were not injuried at that point of time. The van driver is of Chinese ethnicity, seems to be a Malaysian and in his 50s.

I wish to state that I am unable to confirm if my in-car camera was recording as I need to get my workshop to check for me. The damages to my vehicle include scratches to the front left fender which was also misaligned, and dents to the front left bumper and left mirror. The motor of the left mirror is also not working as before, noticeably noisy.


