Take photos of the scene, including vehicles and damaged property before they are moved and video it if possible.

Report to the police - You will need to report the accident to the police if someone is injured, if a hit-and-run situation occurs, or if a government vehicle/property, foreign vehicle, or pedestrian/cyclist is involved.

Towing services - We will arrange for someone from one of our approved service providers to tow your vehicle away quickly. They will verify they are with DirectAsia. Do not use any unauthorised tow-truck operators or touts as this will delay your repairs.
