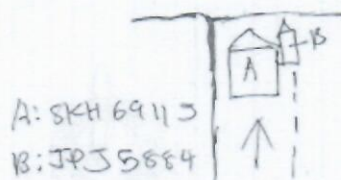

Sketch Plan





