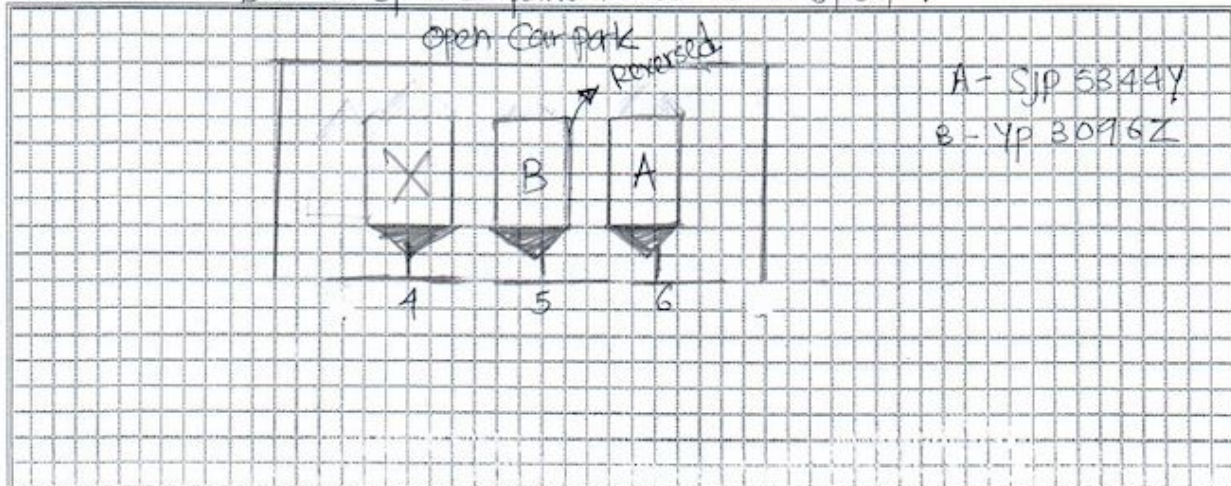

BLK 213 open carpark Bedok north street 1



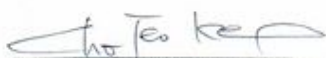
