Brief Details.

I was travelling at 78 km/h on the 2nd lane on TPE towards Changi. The car (SND 3662D) in front was signaling right but did not execute his intention. Instead of moving right, he suddenly jam break with his right signal lights still blinking and came to a stop without switching on the hazard lights (according to car dash cam 23:48:50). I applied the brake as soon as I saw that he jam brake, and my car enacted the emergency brake but could not stop in time and hit the back of the car. There was no injuries to the other driver and myself. After he collided, he explained that there was debris on the road that hit his car, so he decided to jam break. The other driver was not injured and did not get on the ambulance. His MC was above 3 days and therefore we had to write a police report. There was a traffic police present at the scene.
