**Brief Details.**

On 2 Jan 2022 I was driving home from my office at about 1445hrs. My wife and two daughters were in the car (SLL1818X) with me. I was driving along Marina Boulevard and was going to turn into the ECP at the Sheares Avenue junction. I was in the 3rd lane from the left, which is a straight and turning lane. The 1st and 2nd lanes are both turning lanes. The lights were green and I slowed down to turn at the junction.

As I slowed down, I realised that the car in the 2nd lane (SDS8909D) was not slowing down. Instead, SDS8909D was going straight at the same speed, even though the 2nd lane is a turning lane. I came to an emergency stop and sounded my horn to warn the driver. However, SDS8909D did not stop and continued to drive straight ahead down Marina Boulevard towards Gardens by the Bay. The rear right side of SDS8909D hit the front left corner of my car as it drove past. This caused damage to the front left corner of my car.

SDS8909D did not stop at the side of the road after the accident. I thus followed SDS8909D

down Marina Boulevard instead of turning into Sheares Avenue, as I needed to get the driver's particulars. I turned on my hazard lights and followed behind SDS8909D. After a while, SDS8909D turned off into Marina Gardens Drive. I followed. SDS8909D then stopped at the side of Marina Gardens Drive. I stopped behind SDS8909D and came out of my car to take pictures of the damage. The driver of SDS8909D (Della Aristya Tjitra) came out of the car. Another woman came out of SDS8909D as well. I do not know if there were other persons in the car. My wife and my two daughters remained in my car during this time.

While taking photos of the damage, I told the driver of SDS8909D that she had gone straight on a turning lane. She asked how this was going to be settled. I told her that we may need to make a Police report. We confirmed that there were no injuries to the persons in either vehicle. I told the driver of SDS8909D that I would need to bring my car to the workshop to get it repaired. The passenger of SDS8909D said that it would be best to leave this to insurance. I told the driver of SDS8909D that I would be making a claim against her insurance. The driver took a picture of my driving license from my SingPass app, and I took a picture of hers. We exchanged phone numbers (her number is 96316229). I then drove off and went home with my family, who were quite shaken up by the accident.

I have photos of the damage to my car and of SDS8909D. I also have a photo of the driver's driving license. Unfortunately my car's in-car camera did not record footage of the accident. I believe that there is a traffic camera at the junction of Marina Boulevard and Sheares Avenue.
