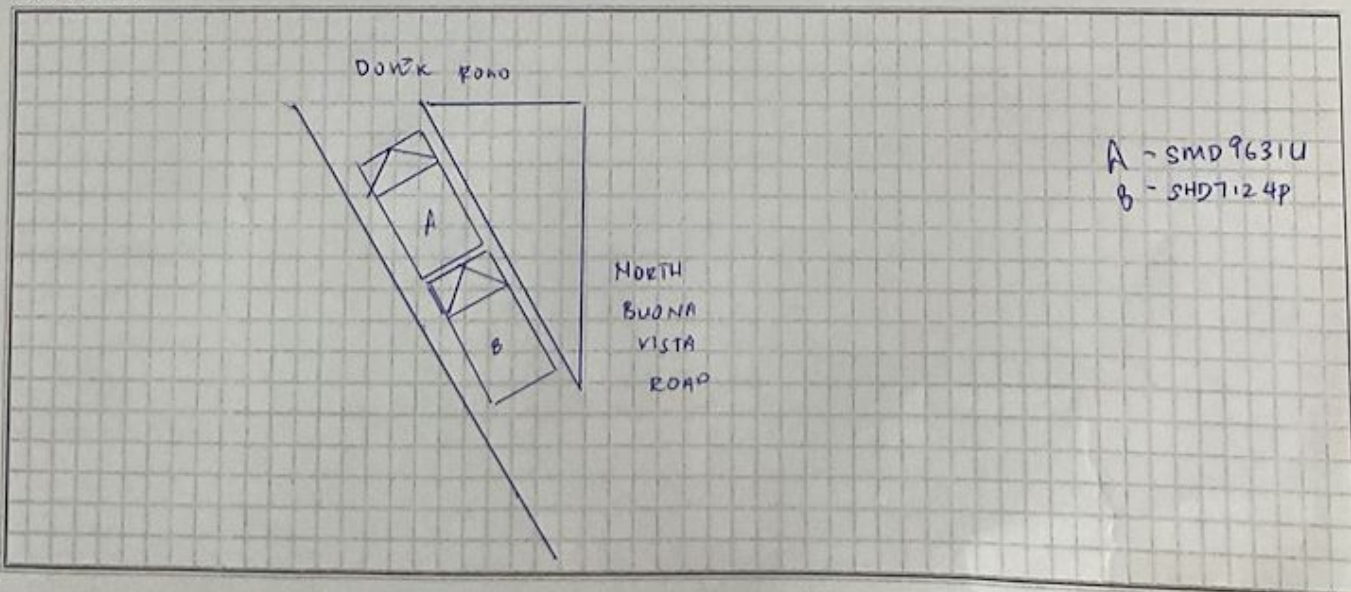


Sketch Plan


