CIRCUMSTANCES OF ACCIDENT

VEHICLE COLLISION BETWEEN DONATUS AND AND ASP MUHAMMAD BALYA (PUNGGOL NPC) ALONG PUNGGOL CENTRAL ROAD TOWARDS PASIR RIS INDUSTRIAL DRIVE 1. ASP MUHAMMAD BALYA (PUNGGOL NPC) WAS ON LANE 1 TURNING RIGHT TOWARDS PUNGGOL EAST WHILE DONATUS ANG WAS ON LANE 2 TURNING RIGHT. BOTH VEHICLES TURNED RIGHT INTO THEIR RESPECTIVE LANES ALONG PUNGGOL EAST HOWEVER ASP MUHAMMAD BALYA (PUNGGOL NPC)'S VEHICLE (GBC5839A) STARTED TO WOBBLE AND SKIDDED TOWARDS RIGHT SIDE. IN MY ASSUMPTION, ASP MUHAMMAD BALYA (PUNGGOL NPC) TRIED TO AVOID HITTING THE KERB AND DID AN EMERGENCY LEFT MANEUVER WHICH CAUSED A COLLISION ON THE RIGHT SIDE OF MY VEHICLE (SMN7022M). THEREAFTER, BOTH PARTIES PULLED TO THE SIDE AND EXCHANGED DETAILS, ASP MUHAMMAD BALYA (PUNGGOL NPC) ASKED FOR MY NRIC AND DRIVER'S LICENSE HOWEVER I WAS NOT GIVEN ANY DETAILS EXCEPT HIS NAME. WE WAITED FOR THE TRAFFIC POLICE TO ARRIVE AT THE ACCIDENT SITE AND I WAS ASKED A SERIES OF QUESTIONS, MY VEHICLE'S (SMN7022M) IN-CAR CAMERA SD CARD WAS SEIZED DURING THIS TIME. AN AMBULANCE WAS DISPATCHED TO CHECK ON THE INVOLVED PARTIES BEFORE BEING RELEASED TO THE TRAFFIC POLICE.

TO ADD ON: BOTH VEHICLES WERE TRAVELLING STRAIGHT ALONG PUNGGOL EAST AND AFTER TURNING RIGHT FROM PUNGGOL CENTRAL. OTHER DRIVER LOST CONTROL OF VEHICLE AND COLLIDED WITH MY VEHICLE.

Vehicle Collision between Donatus Ang and ASP MUHAMMAD BALYA (PUNGGOL NPC) along Punggol Central Road towards Pasir Ris Industrial Drive 1. ASP MUHAMMAD BALYA (PUNGGOL NPC) was on lane 1 turning right towards Punggol East while Donatus Ang was on lane 2 turning right.
