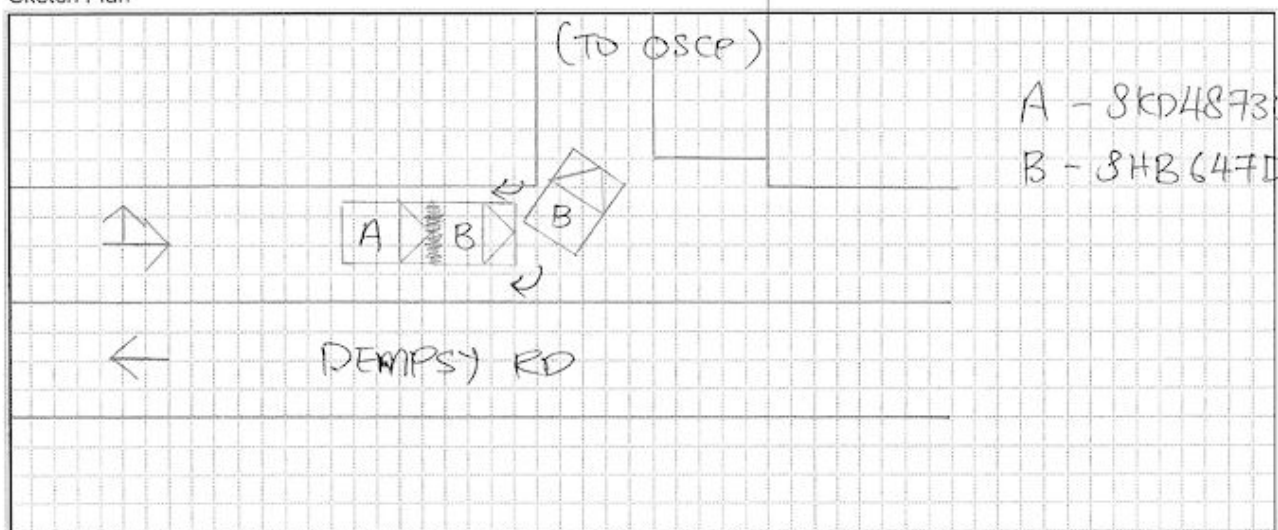

Describe Circumstance of the Accident

ON 21/01/2023 @ 1921HRS, I WAS DRIVING MY VEHICLE A (SKD4873U) ALONG DEMPSY RD (OSCP). BEFORE ENTERING THE OPEN SPACE CAR PARK, MY VEHICLE A (SKD4873U) WAS STATIONARY WAITING FOR THE FRONT VEHICLE B (SHB647D) TO TURN IN TO THE OSCP. SUDDENLY VEHICLE B (SHB647D) ENGAGED REVERSED GEAR AND I HONKED AT HIM BUT HE STILL CONTINUE TO REVERSED AND VEHICLE B (SHB647D) REAR PORTION COLLIDED ONTO THE FRONT PORTION OF MY VEHICLE A (SKD4873U).
