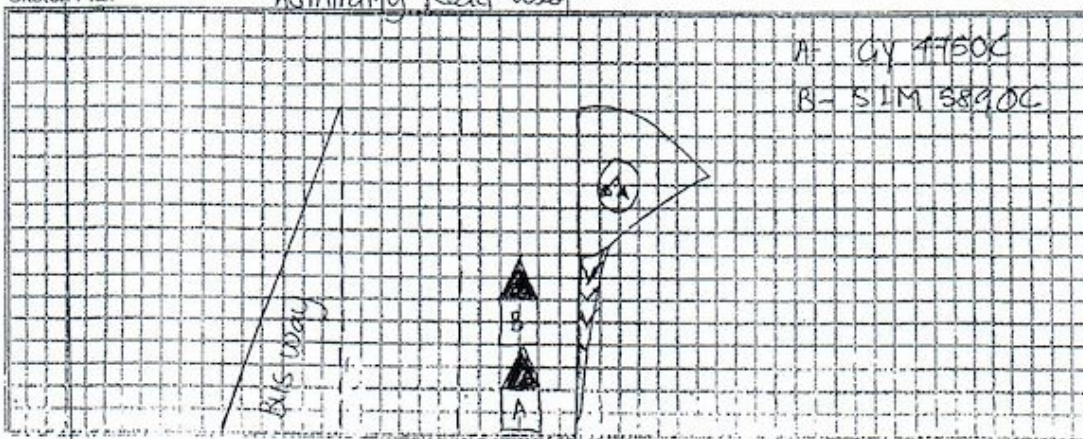

Admiralty Road West




Describe Circumstance of the Accident
