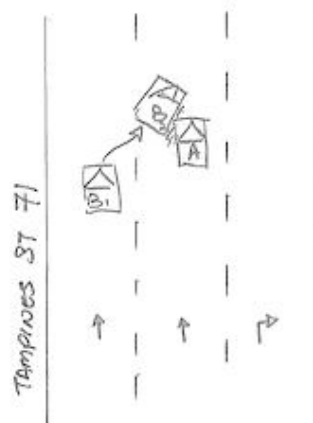

AFTER MY VEHICLE HAD ENTERED INTO THE CENTRE LANES, ONE M/TAXI SH 62234 SUDDENLY FROM THE LEFT MOST LANE SWITCHED TO THE CENTRE LANE AND ENCRONCHED INTO MY PATH THUS COLLIDED ONTO THE LEFT FRONT PORTION OF MY VEHICLE.

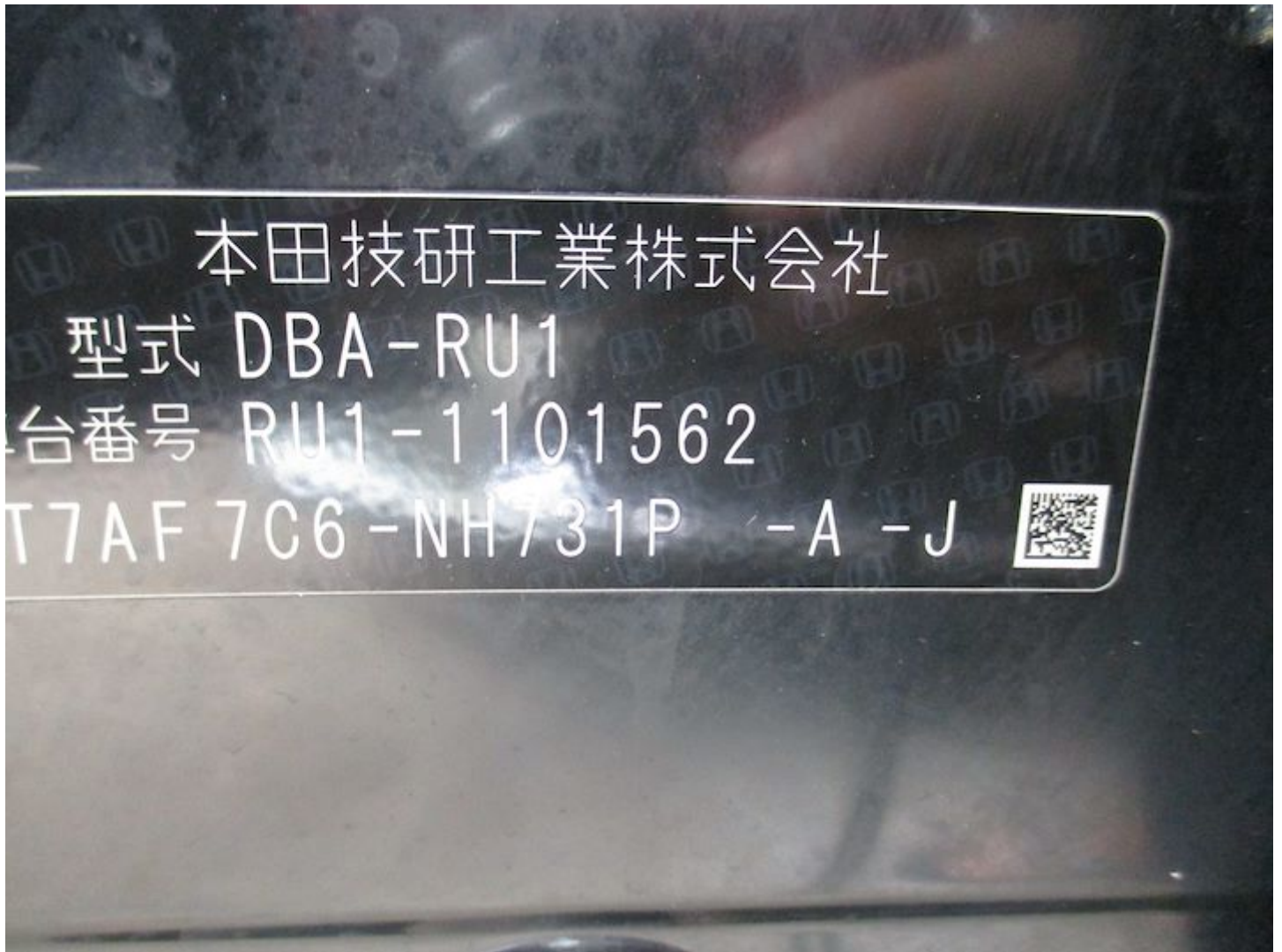

### 1) Hirer / Authorized Driver ("Driver")

TDVL

Hirer / Driver must produce a valid Singapore Class 3 Driving License/NRIC/PDVL/TPVL and guarantee that he / she is not under any suspension order on the License.

### 2) Rates

All rates quoted are in Singapore Currency SGD & include insurance, maintenance and unlimited mileage. Minimum charge is one-day's rate except weekends or public holiday packages.

### 3) Damage to Vehicle

Hirer is also responsible for the full compensation / repair costs including TOTAL LOSS OF VEHICLE payable to P.N. Leasing Pte Ltd if the vehicle breakdown is due to negligence of the hirer/ the driver. Hirer would also be responsible to compensate P.N. Leasing Pte Ltd for the loss of earnings while the damaged vehicle is under repair. If there is an accident that results or possibly result in any Third-Party claim and Company Third Party insurance is involved, the hirer is responsible to pay the Company an excess of the amount as stated in the cover note of the insurance.

### 4) Rental Extension

If the hirer wishes to extend the hiring period, they are to inform P.N. Leasing Pte Ltd one week before the expiry of the contract and advance payment is required for the extension on a case-by-case basis upon the discretion of the Company.

### 5) Terms of Payment

Charges for the duration of the hiring period are payable by the hirer at the time of the return of the vehicle. A final adjustment will be made upon completion of the hiring period. No part of such hiring period shall in any circumstances be refundable except at the discretion of the company. P.N. Leasing Pte Ltd is to pay the deposit back to the hirer 30 days from the end of the hiring period, in which the Company reserves the right to pay any fines or summons incurred by the hirer or the Authorized driver in the duration of the hiring period of the said vehicle.

### 6) Restrictions on the usage of vehicle

Vehicle restriction is solely unto Singapore use only. Hirers shall not take the said vehicle beyond the mainland of Singapore without the written consent of the Company. Failure to comply with the terms and conditions mete out, may entail serious consequences and the hirer shall assume full responsibility in an event of the said vehicle being damaged, confiscated, forfeited or seized as a result thereof. The hirer shall indemnify the Company for all the loss incurred to the full value of the said vehicle. The Hirer/ Authorized Driver covenants to use the vehicle only for lawful and legitimate purposes and not to use the vehicle for any Unlawful purpose/activity. It is with this expressed understanding that the company leases the vehicle to the hirer. The vehicle may only be driven by the Hirer or by persons who have been expressly designated and authorized herein (hereinafter called the "Authorized Driver"). The Hirer/ Authorized Driver must be in possession of a valid driving license and shall at all times drive the vehicle in a careful and skilled manner observing the traffic regulations and laws mete out by the Land Transport Authority of Singapore. The Hirer/Authorized Driver shall refrain from smoking in the vehicle. A cleaning charge of the market price will be levied for any odor caused by smoking or any actions carried out by the hirer.


### 7) Other conditions

If the reason the vehicle described in the schedule of any other vehicle reserved by the hirer prior to the commencement of the period of rental is available at the time of such commencement, the Company shall reserve the right to replace the said vehicle with an alternative vehicle of similar seating capacity and performance. If no such alternative is available, the company shall decline to provide an alternative vehicle in which the hirer will be refunded by the hiring charges and deposit paid by the hirer after offsetting any hiring charges and costs incurred by the Company but shall have no other claim of any kind whatsoever against the Company.

### 8) Bad debts & Refusal to pay due rental

If the said hirer is deemed to refuse or is late in the payment of rental, the Company reserves the right to forfeit the deposit and to repossess the said vehicle. In no circumstances shall the hirer refuse the Company from taking action against these cases in any instances of occurrence, Late payments charges capped at \$10/day.

### 9) No subletting

The Hirer is NOT ALLOWED to sublet or rent the vehicle to a third party, during or within the rental period. If the said vehicle is found to be driven by anyone other than the hirer or the Authorized Driver named in the Vehicle Rental Agreement, the vehicle will be seized by the Company without any refund. If the Hirer lends the vehicle to a third party without notification to the company, and the vehicle is involved in an accident, the Hirer will bear the whole cost of the damage and repair costs of the vehicle rented and the other third-party claims. In any case of the said vehicle being involved in an accident, the Hirer shall inform the Company IMMEDIATELY. No repair is to be done without seeking the Company's approval. If the hirer has repaired the vehicle without the consent of the Company at any workshop that is unauthorized by the Company, compensation of SGD\$3,000 is payable to the company. The vehicle must be refueled using unleaded 95, 98 or V POWER only. The Hirer is REQUIRED to return the vehicle and key / key tag as per condition when he/she rented the said vehicle from the Company. Loss or damaged key tags will be charged at SGD\$100.00. Any damage of the vehicle will be charged to the Hirer according to the renewable repair costs to make good the said damage to the same condition it was at the start of the rental. If the Hirer who drives the said vehicle, is found to have used the vehicle for racing, illegal trafficking or EXITING SINGAPORE without written consent, sublet or lend without any authorization from the Company. Each clause stated in this Vehicle Rental Agreement will be payable as a Compensation of SGD\$2,000.00 to the company and to pay the market value of the car point of time.

### 10) Fines/Offences

In the event of demerit points and composition fines incurred during rent period, HIRER/Authorized Driver is to bear and clear outstanding before deadline.

### 11) Termination

The hiring shall commence on the date and at the time specified in the schedule and shall continue for the period and end on the date and at the time therein as stated unless extended as expressly requested by the hirer in an event of early withdrawal or default of rental payment the hiring is liable for a \$2500 termination charge.
