

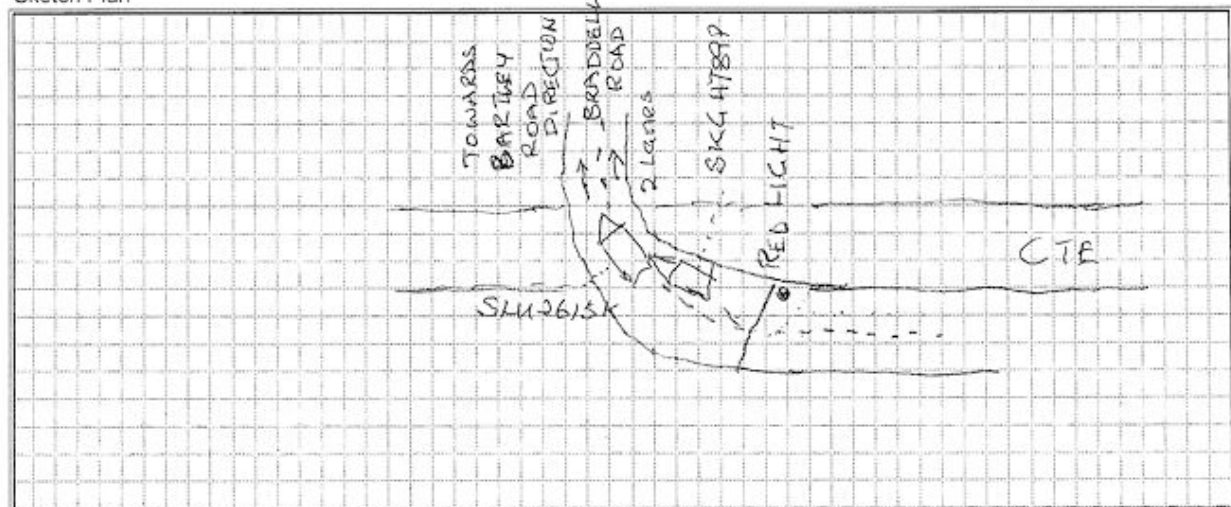


I stop^{ped} after awhile to check the damaged of my vehicle and realised the back Bumper was damage.

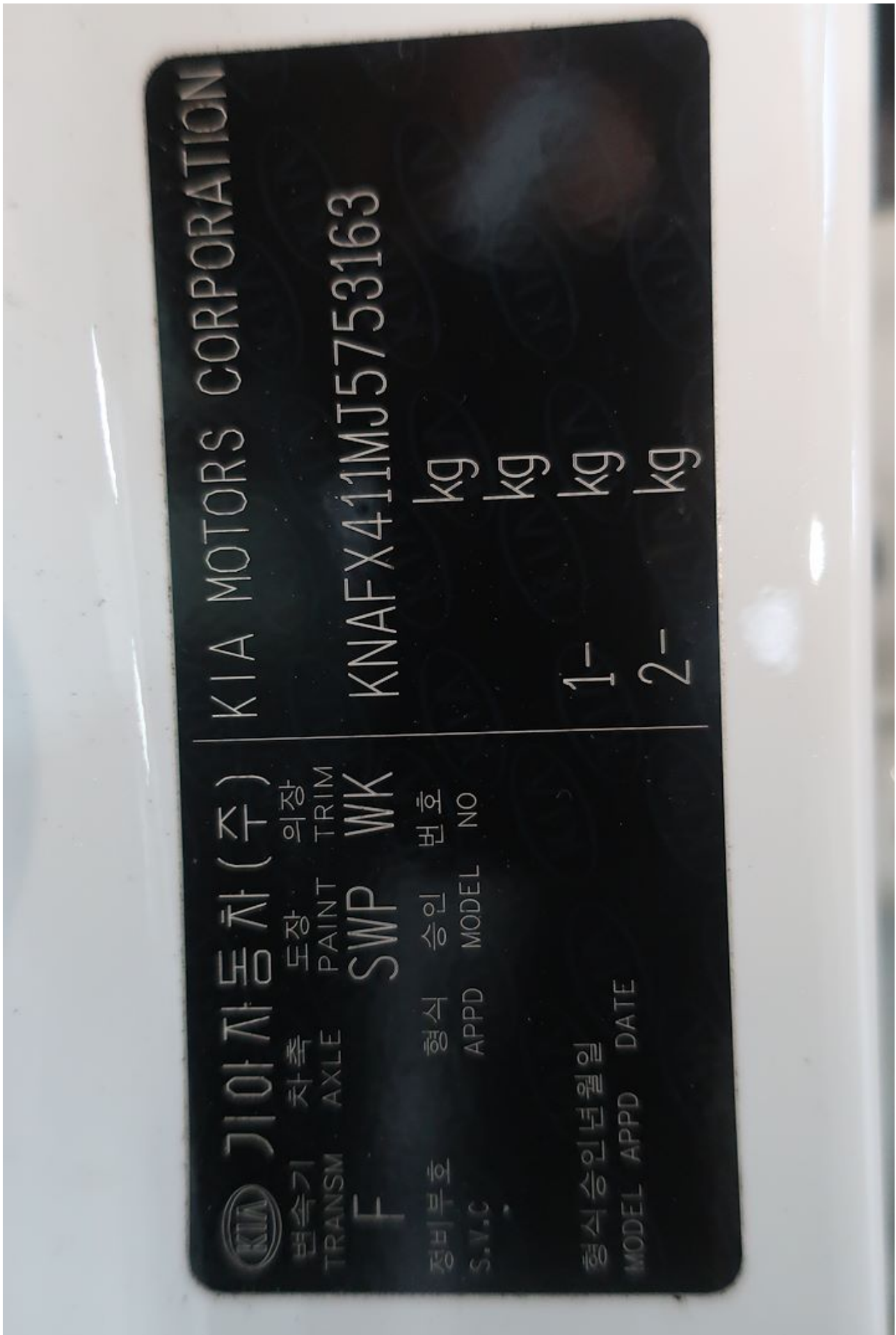
