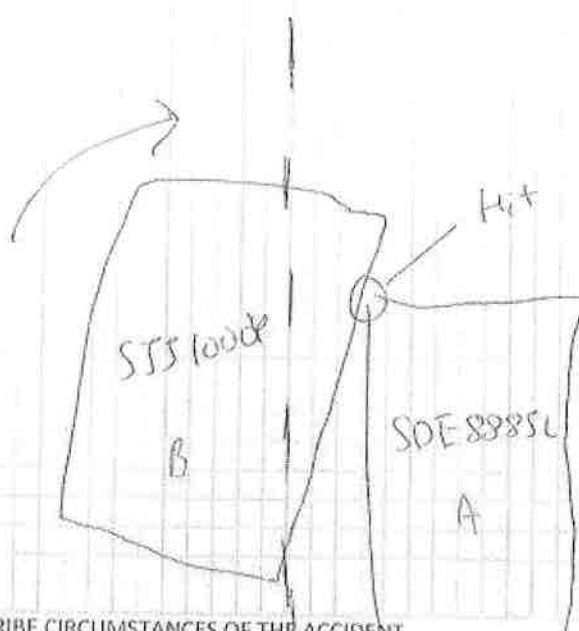

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Accident occurred at 21:46:10 on 23 Jan 2023 about 400m before 2nd mt at JB on the way to Singapore.

I, SDE8885L was keeping my lane when all of a sudden, the car SJS1000Y started making very close to me on the left. There was no signal nor warning. Seeing he was dangerously close, I came to a full stop to let him cut in the lane but my car on the left hand cut / turned at me before straightening his vehicle and continue his overtake. I sent my wife (as I was handling with my vehicle in the brief) to take photos and note the driver's particulars. Driver would drive my window and was aggressive and accusatory and did not want to provide my particulars nor exit his vehicle.

A lady came who was a passenger in SJS1000Y, came down to take photos. They proceeded to drive away after. Video with audio is available.

Brief Details.

Accident occurred at 21:46:10 on the 23 of Jan 2023 about 400m before the Second Link Malaysia Immigration and Custom complex on the way to Singapore Customs. (I am not able to select the exact road name above)

Queueing up for immigration - I was keeping my lane (lanes are marked) when all of a sudden, the car SJJ1000Y started inching very close to me on the left. There was no right signal present. Seeing that he was dangerously close, I decided to come to a full stop and let him cut into the lane. He then inched forward before hitting my car SDE8885L on the left front and stared at me before straitening his vehicle and continuing his overtake.

I immediately sent my wife (as i am physically handicap and my wheelchair is in the boot) to take photos and ask the driver to exchange particulars as an accident had occurred. The driver wound down his window and was aggressive and accusatory trying to argue and had no intension to come out of the car OR share his contact details. A lady came down to also take photos.

Car SJJ1000Y drove off thereafter.

I have sent reported the accident to the insurers and provided them with video (with audio) and pictures of the incident. Please let me know if this is required and i can also provide them to you.
