ON 05/02/2023 AT ABOUT 1500HRS, I WAS DRIVING VEHICLE A BEARING VEHICLE REGISTRATION PLATE, SLQ9272R, ALONG VICTORIA STREET DIRECTION TOWARDS KALLANG JUNCTION WITH OPHIR ROAD ON THE EXTREME RIGHT LANE INTENDING TO MAKE A U- TURN. THE TRAFFIC LIGHT ARROW INDICATED AMBER LIGHT, AS I WAS APPROACHING THE JUNCTION, VEHICLE B SUDDENLY APPLIED JAM BRAKES. I REACTED AND APPLIED BRAKES BUT UNABLE TO STOP ON TIME. MY VEHICLE SKIDDED FORWARD AND LIGHTLY KISSED THE REAR OF VEHICLE B. NOBODY WAS INJURED AT THE TIME OF ACCIDENT.

ON 05/02/2023 AT ABOUT 1500HRS, I WAS DRIVING VEHICLE A BEARING VEHICLE REGISTRATION PLATE, SLQ9272R, ALONG VICTORIA STREET DIRECTION TOWARDS KALLANG JUNCTION WITH OPHIR ROAD ON THE EXTREME RIGHT LANE INTENDING TO MAKE A U-TURN.
