Dear IO Stephanie,

Good day. Refer to your letter dated 02/02/2023, we would like to submit some video footage and photos for your reference on what happened when the accident happened.

In short, my driver, Malaiappan Manikandan had accidentally hit on the rear portion of vehicle SGD6421A. There were three people in the vehicle, the driver, his wife and son. The passenger (his son) jumped down from their car to scold and curse my driver when he was in a state of shocked and Malaiappan Manikandan apologized to him repetitively. The driver of SGD6421A checked his car (Toyota Corolla Altis) and told his son that there is no scratches nor dent to his vehicle, and there is no one injured as well, so he allowed my driver to leave.

Later in the evening, the wife of the driver called Malaiappan Manikandan to ask for \$1500 as compensation for the accident, otherwise they threatened to file police report. She then sent Malaiappan Manikandan the video footage (as attached in the Dropbox).

I advised Malaiappan Manikandan to file accident report when reporting centre opens for business after CNY as they were already closed for CNY when my driver was back from work on the accident day dated 20 Jan 2023.
