**Brief Details.**

On 03/02/2023 at about 1805hrs, I was driving along Raffles Boulevard towards Marina Bay Sands. I stopped at the traffic light junction where I was about to make a right turn on 1st lane. My vehicle (SMJ9637Y) was stationery while waiting for the traffic arrow to turn green, there was a bus (SMB1596B) on the 2nd lane which made an abrupt turn towards the 3rd lane before making a right turn, my vehicle (SMJ9637Y) was hit from the side and sustained damages on the left passenger door and left back bumper. I only managed to take down the name of the bus driver namely Liu MingHua from SMRT as the traffic was heavy, I then drove off the scene.
