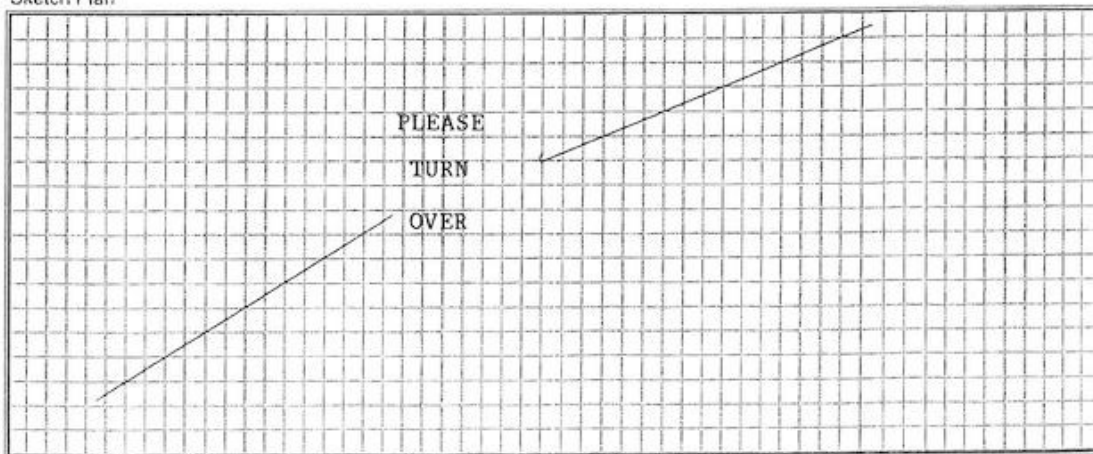

Sketch Plan





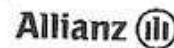
