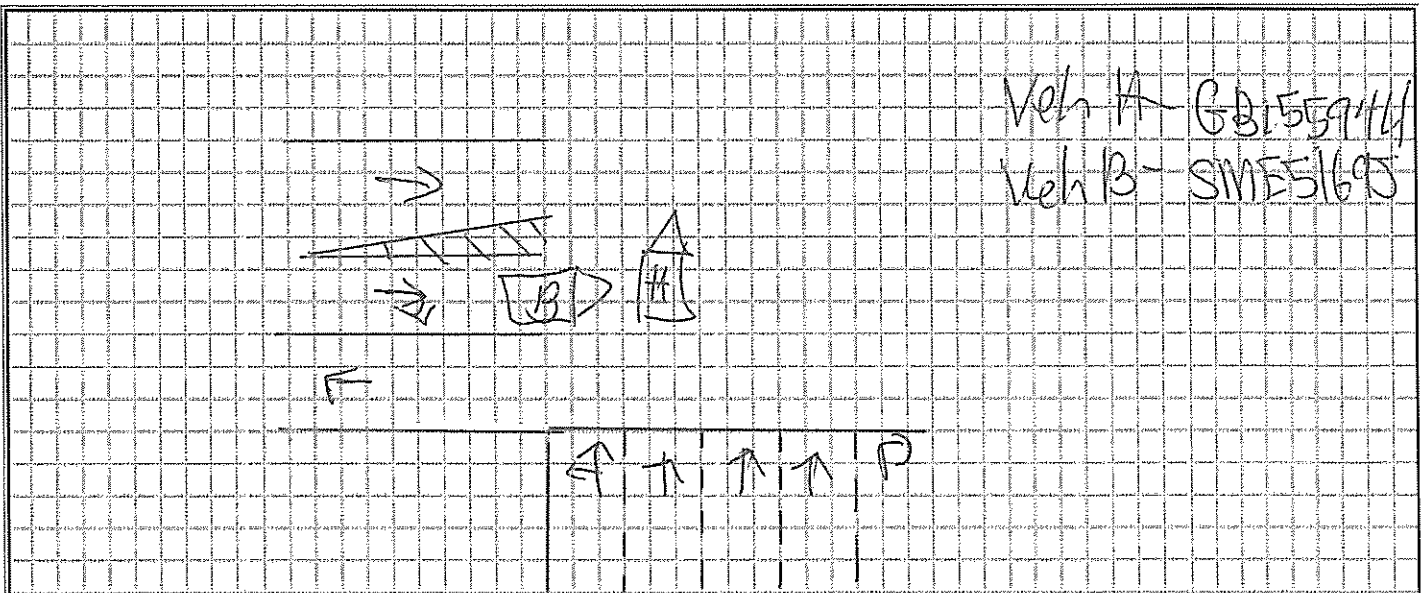

Sketch Plan

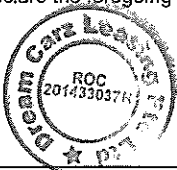


