FACTS OF CASE:

I am the owner and main driver of vehicle number SLG P067B which was involved in an accident on 06/01/2023 at the North Star Building at 1210 hours.

I had finished a delivery around the Serangoon North area and was headed to the North Star Building to pick up an order. I was alone. The weather was clear, traffic was moderate and the road was dry. I was driving along Serangoon North Avenue 4 heading towards Northstar Building. Halfway I fell asleep, by the time I woke up, I had been involved in a head-on collision with another car which was exiting the building. I realized the both the front airbags were deployed. I suffered abrasions on my face and legs. I felt a headache. I exited the car. I retreated by the side to regain my composure. The driver of the other car, a woman approached me. She asked me if I was on alcohol. I denied and told her I fell asleep and apologized. Somebody called the traffic police.

Within 15 minutes a traffic police car arrived at the accident location. The TP officer asked me if I had been drinking I denied again.

STATEMENT

He administered a breathalyzer test which tested negative. He asked if I needed an ambulance. I said no. He then let us go. I called my friend and made towing arrangements to send my car to my regular workshop, Revolution at Panchor Kati Bukit. The tow truck arrived in 15 minutes. I hitch hiked with the tow truck to my workshop. However the workshop was closed by that time at about 2100 hours.

I went there the next day but they told me they are not an Allianz insurance workshop. So I filled in the accident statement at Revolution and they helped me tow my car to SME Motor Pte Ltd to do the accident reporting. I did not seek medical attention as my injuries weren't severe.

If I remember correctly, around 29th or 30th January 2023 I was contacted by a TP investigative officer (IO). He asked me the circumstances of the accident and told me to make a police report because the third party had sustained personal injuries. I made a police report at the Simei NPC on 31st January 2023. The TP IO did not tell me that I may need to come down to TP HQ if needed.

I do not have footage of the accident as my in car camera was destroyed in the accident. However I obtained a leaked footage posted online. It showed that I entered the North Star building from the ~~ext~~ gentry and was travelling at constant speed mounted the centre kerb and entered the North Star building from the ~~ext~~ gentry which led to the collision with the 3rd party. in December 2022. (Platinum Motoring, Defcon).

I bought this car used from a dealer. The COE was renewed 10 years. It had about 6 years left. The only ~~a~~ I only changed the ms of the car. The open port air filter, aftermarket exhaust, gauges, speedometer, the pedal shifter ~~turn~~ - blow off valve ~~was~~ all carbon fibre rear spoiler were all fitted by the ex-owner. I asked the salesman Darren for the exhaust certificate but he told me it's street legal and that everything is ~~on~~ in the system online.

I wish to state that I did not consume any alcohol or take any medication that may cause drowsiness and could impact my ability to drive on the day of the accident.
