### Brief Details.

On 30/05/2019 @ 0645hrs, I entered Singapore through Woodlands Checkpoint to meet my friend at Sentosa. I am driving a White Hyundai Starex with registration plate number: JSG1661.

At 0700hrs on the same day, I was driving along BKE towards PIE, just before turning into PIE. I was driving on the first (outermost) lane. As the traffic was slowing down, I applied the brakes to slow down my vehicle. However, despite stepping on the brakes, my vehicle still slid forward and collided with a blue car with registration plate SKZ2846X. As a result of the collision, the blue car also hit another car in front. I wish to note that the road surface was a bit wet at the moment of the incident.
