MY FRIEND HELP CHECKED IF ANY DAMAGE TO MY CAR AND REALISE THE DAMAGE AT THE BUMPER LIPS. I TEXTED MY AUDI ADVISOR ON THE DAY OF ACCIDENT TO CHECK ON THE PRICE FOR REPLACEMENT FOR THE ITEMS BUT RECEIVED A MESSAGE THAT IT WAS ON LEAVE TILL 30 JAN 2023. CONTACTED ERIC, MY AUDI ADVISOR ON 31 JAN 23 AND THE CLAIM DEPT CALLED ME TO FILE FOR ACCIDENT CLAIM. AS I WAS WORKING, I ONLY MANAGED TO DROP BY TO SETTLE THE CLAIM ON 6 FEB 2023 AT ABOUT 1715HRS.



A truck ran over a big stone, and it roll over to my
lane on the left. I drive over the stone and heard a
lot sound. When I reached my friend's place at BLK
676B Punggol Drive Carpark. My friend help checked if any
damage to my car and realise the damage the the
bumper lid.

I texted my Audi advisor on the day of accident to check on
the price for replacement for the items but received a
message that he was on leave till 30 Jan 23. Contacted
Eric, my audi advisor on 31 Jan 23 & the claim dept called
me to file for accident claim. As I was working, I only
managed to drop by to settle the claim on 6 Feb 23 at
about 17.15hrs.
